RESOLUTION TO CHANGE ELECTIONS SCHEDULE FOR THE ANN ARBOR DISTRICT LIBRARY BOARD OF TRUSTEES TO NOVEMBER OF EVEN YEARS TO ALIGN WITH ANN ARBOR PUBLIC SCHOOLS CHANGE OF ELECTION DATE

Minutes of a regular meeting of the Board of Trustees of the Ann Arbor District Library, County of Washtenaw, Michigan, held in the City of Ann Arbor, on the 21st day of December, at 6:00 p.m.

PRESENT: Head, Leary, Murphy, Rosenthal, Stearns, Surovell

ABSENT: Barney Newman

The following resolution was offered by Treasurer Rosenthal, and supported by Trustee Murphy:

WHEREAS, Public Act 24 of 1989, as amended, provides that elections for the Ann Arbor District Library ("Library") Board of Trustees shall be held at the same time as the elections for board members of the Ann Arbor Public Schools ("School District");

WHEREAS, pursuant to the provisions of Public Act 24 of 1989, as amended, the Library has traditionally held its Board elections at the same time as the School District board elections, in May of each even year;

WHEREAS, Public Act 302 of 2003 and Public Act 292 of 2004 provide that all School District board elections shall be held at the odd-year November general election, unless an alternative election schedule is selected by the School District board;

WHEREAS, pursuant to the provisions of Public Act 302 of 2003 and Public Act 292 of 2004, on December 16, 2009, the School District board approved a motion to hold its board elections annually in November;

WHEREAS, Public Act 302 of 2003, Public Act 286 of 2004, and Public Act 287 of 2004 provide that School District board elections shall be administered by the Washtenaw County Clerk and the school district election coordinating committee;

WHEREAS, Public Act 24 of 1989, as amended, and Public Act 302 of 2003, Public Act 286 of 2004, and Public Act 287 of 2004, when read together, indicate that the Washtenaw County Clerk and the school district election coordinating committee also shall administer Library Board elections;

WHEREAS, the Board wishes to continue to hold Library Board elections at the same time as School District board elections, and to have Library Board elections administered in the same manner as School District board elections:

THE BOARD RESOLVES:

- 1) That the Board of Trustees of the Library changes the elections for Library Board members to November of even years, at the same time as Ann Arbor Public School District Board elections.
- 2) That a copy of this Resolution shall be transmitted to the Washtenaw County Clerk with a request that provisions for Library Board elections be included in the Ann Arbor Public School District election coordinating committee's report to the Michigan Secretary of State.
- 3) That all resolutions that conflict with the provisions of this resolution are rescinded.

Ann Arbor District Library Financial Summary for December 2009

Cash:

The unrestricted cash balance as of December 31, 2009 was \$12,392,701 down from \$13,551,206 in November.

Tax Receipts:

The Library has received tax receipts totaling \$11,152,225, 95% of the budgeted amount, as of December 31st.

Budget vs. Actual:

The Library showed an operating surplus of \$242,232 through December 31st. This gives the Library a positive fund balance of \$7,122,959 at the end of December, up from \$7,004,160 in November.

Year-to-Date Revenue (Budget vs. Actual):

Tax and penal fine revenues are being recognized monthly at the monthly budgeted amount. This line item will be reconciled with actual receipts at the end of the year.

Year-to-Date Expenditures (Budget vs. Actual):

The following operating expense line items, all of which should fall back into line later in the year, are over budget through December:

Salaries, Wages and Taxes – Lump sum payments for merit increases were paid in July.

<u>Custodial</u> – Carpet and window cleaning took place in July.

<u>Purchased Services</u> - An annual payment of approximately \$40,000 for OCLC was made in July.

Communications – A payment for internet access was made in October.

 $\underline{Software\ Licenses}$ – A large payment of approximately \$60,000 was made in July putting this line item over budget.
