Hello everybody, I'm Don Lawson, I'm from Pace Mechanical Services and I'm not a resident of Ann Arbor but I'm a longtime resident of the area. I just wanted to be here, I know you plan on discussing the PMA agreement and just wanted to show up, just make a few comments. I've been actually servicing the account for four years for Pace Mechanical and prior to that with Campbell, Incorporated who's our other mechanical company. Just wanted to let you know that we've been taking good care of the equipment. Some equipment's aging, but its running rather well because we have taken care of it. If anyone needs anything answered I'd be more than happy to answer any questions. Thank you.

#### Dominic Cuda

Thank you for your time, I appreciate it very much. I'm with Campbell Incorporated and we're a community company here in Ann Arbor, Michigan, and we have been for over fifteen years. I guess, what I would like to understand is the Ann Arbor Library itself, is so dependent on the community for support and here we are a local company in town paying taxes here, employing people from the local area here, we're planning on putting up a building or buying a building to expand our business, etcetera. So I'm just thinking to myself, and I'm trying to understand, if I can, how come the Library isn't looking at a local contractor in town, whether it's us or Fuller or Robertson Morrison, why are we going outside of this area and not looking at local companies that are paying taxes in this town, supporting it with people from the area, etcetera. I myself am involved with the Ann Arbor arts, I'm involved, I do much work with the University of Michigan with the Dawson's. I've spent thousands of dollars personally at Mediterrano and all sorts of restaurants and places in town with family and friends in community and I guess I'm just trying to understand why a company like Campbell, Inc. could not be given the opportunity to be the contractor of choice. If we're here in this community providing so much support. That's my only comment and I mean it very respectfully to everyone here. Thank you.

#### 10-241 VI. FINANCIAL REPORT

Director Parker reported May revenue is at 99% of the budgeted amount for tax receipts. The outstanding one percent is payment from the county for tax delinquencies. State aid received by the Library is at 50%. \$35,000 to \$40,000 is anticipated, but not budgeted as annual receipt has been tentative for a number of years. This is a drop from the \$120,000 we usually received due to

our withdrawal from TLN and not joining another cooperative.

# **Ann Arbor District Library Financial Summary for July 2010**

#### Cash:

The unrestricted cash balance as of July 31, 2010 was \$6,374,166 down from \$7,582,574 in June.

#### Tax Receipts:

The Library has received tax receipts totaling \$125,934, 1% of the budgeted amount, as of July 31st.

#### **Budget vs. Actual:**

The Library showed an operating deficit of \$9,906 through July 31st. This gives the Library a positive fund balance of \$7,477,574 at the end of July, down from \$7,616,302 in June.

#### Year-to-Date Revenue (Budget vs. Actual):

Tax and penal fine revenues are being recognized monthly at the monthly budgeted amount. This line item will be reconciled with actual receipts at the end of the year.

#### Year-to-Date Expenditures (Budget vs. Actual):

The following operating expense line items, all of which should fall back into line later in the year, are over budget through July:

Employee Benefits – This reflects the increases in healthcare costs that became effective on July 1<sup>st</sup>. We are currently implementing cost saving measures that should turn this variance around in the second half of the year.

Utilities - The actual costs were a bit higher than budgeted in July.

Communications - A payment for the annual maintenance for the phone systems was made in July.

<u>Software Licenses</u> – A large payment of approximately \$60,000 was made in July putting this line item over budget.

<u>Circ Supplies</u> – A large purchase was made in July.

### Ann Arbor District Library Financial Summary for August 2010

#### Cash:

The unrestricted cash balance as of August 31, 2010 was \$12,598,227 up from \$6,374,166 in July.

#### Tax Receipts:

The Library has received tax receipts totaling \$6,955,532 61% of the budgeted amount, as of August 31st.

#### **Budget vs. Actual:**

The Library showed an operating surplus of \$50,845 through August 31st. This gives the Library a positive fund balance of \$7,606,410 at the end of August, up from \$7,477,574 in July.

#### Year-to-Date Revenue (Budget vs. Actual):

Tax and penal fine revenues are being recognized monthly at the monthly budgeted amount. This line item will be reconciled with actual receipts at the end of the year.

#### Year-to-Date Expenditures (Budget vs. Actual):

The following operating expense line items, all of which should fall back into line later in the year, are over budget through August:

Employee Benefits – This reflects the increases in healthcare costs that became effective on July 1<sup>st</sup>. We are currently implementing cost saving measures that should turn this variance around in the second half of the year.

Communications – A payment for the annual maintenance for the phone systems was made in July.

<u>Software Licenses</u> – A large payment of approximately \$60,000 was made in July putting this line item over budget.

<u>Supplies</u> – A large purchase of supplies for the WLBPD was made in August.

<u>Circ Supplies</u> – A large purchase was made in July.

Other Operating Exp. – A couple large payments were made in August.

1. Three new content partnership projects were completed/finalized in the past month. The Huron Valley Community Network, a volunteer organization that provides free professional web hosting to local nonprofits and groups, has relocated their server from the County's datacenter to AADL's datacenter, allowing them to provide a wider range of services to a wider range of organizations. HVCN handles all interaction and support for their members while AADL provides power, bandwidth, and network support to HVCN. See more at http://hvcn.org.

In addition, Washtenaw Literacy launched their new site in August which included a move onto AADL's community projects server. WL is responsible for the design, development, and maintenance of their site while AADL provides server resources and web hosting support. See the new site at http://washtenawliteracy.org.

Finally, the Legacies Project, a local nonprofit focused on connecting teens and elders through the production of video oral histories, launched its site in early September as a part of the aadl.org site portfolio. The Legacies Project teaches teens to interview, record, edit, and tag video of local elders and advances the state of the art of oral history digitization. The Legacies Project videos become a part of aadl.org's digital content collection and will ultimately be searchable along with our other local history resources. The Legacies Project conducts workshops to train the teens, matches them up with local elders through community groups or senior centers, records, edits, and organizes the video, while AADL provides the server resources, bandwidth & storage, and software infrastructure needed to handle, preserve, and provide permanent access to the video online. - 2. An alert system for A-Ride passengers has been installed at the Downtown Library. The AATA paid for this installation. The system is activated by the driver on a keypad on the exterior of the building at William Street. Passengers waiting in the lobby of the Library can see a flashing blue light or hear a beep followed by a recorded voice announcing that their ride has arrived.
- The Downtown Library entry has been redesigned due to construction to the north of the Library. The DDA, in cooperation with AADL, managed the project and covered all costs associated with the new barrier free entry. In addition, new lighting has been installed by Christman Construction all along the front of the Downtown Library.
- 4. Janet P. Smith retired from the AADL on August 31, 2010. A librarian and cataloguer, Janet served as Manager of Access, User Services and Collections in her latest position. Her contributions are most evident in the ease of the experience for patrons locating material in the online catalog. Her interest in Local History and genealogy led to offerings such as computer searching classes and special collection enhancements in the past few years. Janet will be missed

#### I. PROBLEM STATEMENT

One of the two chillers at the Downtown branch is in need of major repairs or replacement.

#### II. BACKGROUND

The two existing chillers were installed and commissioned in 1989. The average lifespan of such equipment is approximately 20 to 30 years. One of the chillers recently lost refrigerant in stage two, due to a condenser fan bracket cracking and shearing apart. The fan and bracket fell into the coil section and major damage occurred to the condenser coil.

The best time to repair or replace this piece of equipment would be late fall or winter. The lead time for the equipment is approximately eight weeks, Pace Mechanical has prepared three quotes after discussions with the manufacturers of the equipment.

#### III. OPTIONS

- 1. Repair the current chiller by replacing the damaged condenser coil \$63,927.00.
- 2. Replace the chiller with a new Trane chiller \$112,600.00.
- 3. Replace the chiller with a new McQuay chiller \$108,555.00.
- 4. Do nothing.

#### IV. RECOMMENDATION:

Option 3: Authorize Pace Mechanical to install the new McQuay chiller at a cost of \$108,555.00.
