Gentlemen: Your committee on sidewalks have had the several matters referred to them under careful consideration and are pleased to submit the following report: That it is deemed and declared to be a necessary public improvement to order a tar walk constructed and built on the north side of W. Jefferson, between Third and Fourth streets.

Referring to the sidewalk on the north side of E. Ann street, between Glen ave. and Clark street, we would ask the City Engineer to furnish profile and estimate of cost for grading said walk.

The accompanying cut of city map shows Scott street, between Israel ave. and Wells street. And therefore to establish a sidewalk grade on the west side of Martin street, we would ask that the City Attorney ascertain what rights the city has to establish a walk leading into Lincoln avenue.

Furthermore that the Board of Public Works be ordered to remove all dangerous plank walks on the west side of Seventh street, and that the question of grading and widening said street be referred to a special joint committee of five, with the President of the Council to act as chairman.
