Matter of Ashley street pavement to be taken up later in the evening. To the Honorable the Common Council:

Gentlemen—At the request of the special water committee and the Com-

mon Council, the board of health, on Tuesday, May 9th, made an inspection of the plant of the Ann Arbor Water Co. with regard to its sanitary condition, and begs to submit the following report of its findings:

First, The Upper or River Station.

This station is situated on low ground near the river. There are a group of deep located here (1) into wells discharging flowing "gallery" or deep walled in trench, from which the water is carried by tile, wood or iron pipes to the settling (2) Three deep six-inch wells basin. and one two and one-half-inch well discharging into a covered cistern whence the water is pumped or siphoned through a separate iron pipe to the receiving basin. (3) Two deep wells near the engine house, supplying condensing water. (4) The rebasin. (5) An emergency (6) The boilintake from the river. ers and pumps.

"gallery" is situated toward the southwest corner of the company's land. Its walls are of brick and cement below, above of sound The roof is made of oak lumber. hemlock boards, as it is necessary to remove it at frequent intervals to clear the pipes of sand. The gallery is provided with a door, which is kept We saw no signs of rotten lumber of which complaint had been made, except that an old wooden casing, inside of which the newer oak one was built, was left in its original position. There seems to be nothing uncanitary about this. We have also heard complaints that this ground was used as pasture for cows and horses; that there were piles of manure in the neighborhood of the gallery, and that there was danger of the water being contami-We find that there nated thereby. are no cattle pastured here, but that one horse 's occasionally allowed to graze over the ground. There were no conspicuous deposits of manure, and it is difficult to see how, even if

they were present, they could contaminate the water of these deep wells or the pipe which carries the water to the receiving basin, which runs at the gallery some fifteen feet below the surface and has tight joints. only apparent danger here is the one which the company has recently endeavored to obviate. During floods which have occurred during the past two years this land has been covered by the wash from the hills above, and occasional slight contamination has occurred through leakage into the gallery. The company has recently put in a new drainage d'tch above the gallery, which it is hoped will overcome this difficulty. It is a thing which can certainly be remedied at no very great expense.

The water is carried from the gallery through a cement-jointed tile to a point near the railroad track where formerly the water from the "Allen spring," now abandoned, joined it, thence for a short distance through a wooden pipe, thence through an iron pipe to the settling basin.

The second group of wells mentioned are driven, as are all the wells at this staton, through a deep stratum of impervious c'ay. The water is discharged into a roofed-over brick and cement ci tern; from there pumped or sighoned through an iron pipe to the receiving basin. There seems to be no occasion for criticism here

The two wells for the condensing water are 100 feet or more in depth, and go through the same clay stratum. There is no likelihood of their being contaminated.

The river intake is there for emergency use and we have no reason to believe that water is pumped through it without proper warning.

The receiving basin is an open basin into which the water from the wells flows and from which it is pumped to the upper reservoir. It seems clean and the banks are neatly kept. It is not fenced in, but as the only probable contamination would be malicious and as at least one employe of the company is constantly on hand to watch it, it seems doubtful whether fencing would be of any advantage. The basin is open to cinders, etc., from the railway, which offer no dangers from a sanitary point of view. Otherwise, it is rather an advantage to have it open to sunlight.

There is one house upon the company's property and we understand that it has a separate drain to the river.

On the whole, we believe the sanitary conditions at this station to be excellent. There is very little possibility of any contamination of the water here, and practically none whatever of the only kind of contamination that is really serious—namely, that by human excreta. It is this kind of contamination that makes the water likely to spread the so-called "water-borne disease," of which typhoid fever is the chief example.

Second, the Reservoir.

We found nothing to criticize here. The reservoir is clean and well kept, and by its position above danger of institution but malicious contamination, which is provided against by a close, high fence.

Third, the Washington Street Station.

There are here three groups wells. West of Eighth street there is a group, all but two of which are rather shallow—from 30 to 40 feet. The wells lie in a depression, while on a hill above and some two or three hundred feet away are some privies belonging to houses facing on Liberty street. The most serious objection that has been made to the water supply is that the water of shallow wells might be contaminated drainage from these Theoretically it seems to us doubtful whether such contamination would take place under present conditions. as the drainage from these places must travel some two hundred feet through coarse sand, which is in itself a most efficient water filter, and as the wells are cased to a depth of thirty feet or more, which would prevent contamination from the surface water of the immediate neighborhood. As a matter of fact. these privies were there when the wells were first driven and analysis made at that time at the hygienic laboratory gave no evidence of anything like sewage contamination, nor has any one of a number of subsequent examinations shown any sign of contamination of any of the wells at this station. Mr. Leverett, also, has carried on investigations of the temperature of these wells and other wells of various kinds in the same region, which go to show that there is at present no evidence of contamination of the water works wells by surface water.

Circumstances might, of arise which would make it unsafe to use the water of these wells. building of any large number privies on the hill above, for instance, might cause a contamination of the wells which would render the water unfit for drinking purposes. hardly necessary for us to point out, however, that it is within the power of the Council to prevent any such building or to do away with those already there whenever it seems desirable.

The second group of wells at this station lie between Eighth street and the pumping station, and the third group is on the north side of the station, but as the conditions practically identical they may be considered together. They are all deep wells-upwards of ninety feet-and all driven through a thick stratum of hard clay; so that, although there are number of houses, privy vaults, etc., in the immediate neighborhood, we think there need be no fear of drainage from them reaching The water from these wells, also, was examined when the wells were first put down and no evidence of sewage contamination found.

During our tour of inspection samples of water were taken as follows and subjected to bacteriological examination at the hygienic laboratory:

- 1. Water from gallery at upper station.
 - 2. Water from receiving basin.
 - 3. Water from reservoir.
- 4. Water from one of the shallow wells above Eighth street.
- 5-6. Mixed water from all the wells at Washington street station.

Samples Nos. 4 and 5 showed no growth whatever. The slight other four showed very growth, and a portion of each culture (1 c.c.) was injected into a guinea The culture from sample No. 2 killed the guinea pig; the others were Further harmless. examination showed that the germ which caused death in sample No. 2 was not one which is harmful to man, nor did it belong to the group which is associated with sewage contamination. The absence of the organisms of this group from any of the samples examined is pretty good evidence that the wells are not at present contaminated by sewage.

As the result of the investigation we believe that there is no present reason for fearing any serious or dangerous contamination \mathbf{of} the city water supply. The present conditions might at some future time be so changed as to render it inadvisable to make use of the water from some of these groups of wells, but as things stand now we think the city fortunate in having a safer and more palatable water for drinking purposes than most cities of Michigan.

One thing is to be regretted: That there should ever be occas on—and fortunately it is only rarely—to make use of the intake from the river; for, although warning be given to the people to boil the water, there will always be a large percentage who will not do so and there is, of course, some possibility of serious contamination of the river water.
