Engineer's estimate on Lateral Sewers No. 14 and No. 15.

Gentlemen:—In accordance with your resolution and the ordinance governing the construction of lateral sewers, I report on sewer for Sewer District No. 14 as follows: This sewer will connect with the present sewer at the corner of Israel avenue and Baldwin avenue, extend east on Israel to Washtenaw avenue, southeast on Washtenaw avenue to Ferdon Road, south on Ferdon Road to the south line of Dr. Warthin's property and on Vinewood boulevard from Washtenaw avenue to Wayne street.

MISCELLANEOUS BUSINESS.

To the Honorable the Common Council.

Gentlemen:—Your committee on garbage, to whom the question of gar-

bage was referred, beg to report that we have gone over the question thoroughly. We have advertised for and received bids for gathering and disposing of all garbage, tin and glassware in the city, at a total expense to the city of \$2,000 per year. The committee divided the city into four districts and would recommend that cantracts be made with Charles Horton for District No. 2, Emiel Melcer for District No. 4 and J. W. and Wm. Beranek for Districts No. 1 and 3. Provided, That no piggery be located within one mile of the city limits. and that the above parties execute a bond in the sum of \$300 for each district for the faithful performance of the contract. Your committee would further recommend that a suitable ordinance, rules and regulations be adopted for the proper carrying out of the object in view.

Your committee would respectfully ask to be discharged from further consideration of this subject.
