Street Committee. Pavement Resolution

By Ald Sweet:

Whereas, this Common Council has been applied to in writing by a majority of the owners of the lands, which are liable to be assessed for the payment of the construction of the same, praying for the grading and paving of the following pavement districts: District No. 75, on Broadway (outside the center twenty feet thereof) between the northerly line of Swift street and the northerly line of Maiden Lane; District No. 76, on the east half of South State street from the south line of Granger ave. to the south city limits; within the corporate limits of the City of Ann Arbor, Michigan, and

Whereas, the grading and paving of the above named districts, within the limits aforesaid, is deemed and decared to be near somy public improvements; therefore be

Resolved, that it is hereby declared to be the purpose of the Common Council to cause the above named districts, within the limits aforesaid, to be graded and paved under the charter and ordinances of the city of Ann Arbor, and in pursuance of the prayers of said petitioners.

Resolved, further, that the cost and expense of the construction of said public improvement, Pave-District No. 75, shall be charged, assessed and paid as follows: The State Highway Department will construct a pavement twenty feet in width for the entire The City length of said district. of Ann Arbor to pay for street and public alley intersections outside that part constructed by the State Highway Department and the City to pay twenty per cent of the cost

of a portion of said district pavement to be thirty-one feet wide and also the entire cost of remaining width estimated to be thi:teen feet, the entire width, including portion to be paved by State Highway Department, being sixtyfour feet between present contrete gutters; and the remainder, eighty per cent of the cost of a portion. of said district pavement to be thirty-one feet wide, shall be assessed and paid by special assessment levied and assessed according to benefits on and against all the lands, tenements and premises lying on or fronting the above named district, within the limits aforesaid.

Resolved, further, that the cost and expense of the construction of public said improvement. ment District No. 76. shall charged, assessed and paid as follows: All street and public alley intersections and twenty per cent of the remaining shall be paid by the city and the remainder shall be assessed and paid by special assessment levied and assessed according to benefits on and against all the lands, tenements and premises lying on or fronting the above named district, within the limits aforesaid.

Resolved, further, that the said petitions along with this determination be and the same are hereby referred to the Board of Public Works to report to the Council with all convenient dispatch, suitable plans, with sepecifications for the said proposed improvements, the kind and quality of material to be used therefore, together with an estimate of the probable cost and expense of such public improvements.
