# Flowing Wells for City Supply.

The Ann Arbor water works company have been exceedingly fortunate of late in finding water in great abundance on their property. They now have seven flowing wells which furnish 800,000 gallons of water a day. This is in addition to their previous abundant supply of water and assures the city from water famine for many years to come. The wells are from 50 to 65 feet deep and have all been bored in the twelve acres of land the company owns near its works. The wells are forty feet above the river bed. A test well put down last week flowed 85,000 of it another test well was put down Wednesday and flowed freely and with great force; yet the supply in the first was not in the least diminished. The wells threw up stones as large as dove eggs. The company and the city are alike to be congratulated on the discovery of these flowing wells.

### Regents' Meeting.

The regents, Wednesday, elected D. J. N. Martin a full professor in the medical department and appointed Justice Brown, of the U. S. Supreme Court, lecturer on admiralty law and George B. Lothrop, of Detroit, lecturer on patent law. Dr. Abel was given \$600 to fit up his laboratory in materia medica and therapeutics.

No vacancies in the law department were filled. Dr. Carrow was granted \$50 for the purchase of electrodes for use in the hospital. The petition of the city of Ann Arbor for two beds in the hospital was deferred until the next meeting.

The following degrees were conferred: Miss Marietta Kies, Master of Philosophy; Joseph Michael Gries, Pharmaceutical Chemist.

Dr. Breakey was continued as lecturer on Dermatology for the second semester.

Prof. Dennison was granted \$300 for the purchase of models and illustrations for use in his classes in

A guarantee fund of \$500 for the Commencement concert was granted.

The Regents authorized the purchase of the geological maps, which belonged to the late Dr. Winchell, for the University.

Dr. Nancrede was granted \$82 for the purchase of instruments.

Prof. Hinsdale was granted leave of abscence in order to go to Europe next year for study.

The question of foreign fees was brought before the board by a motion to increase the tuition of "foreign" students by \$10. The matter was deferred until the next meeting.

Prof. Reighard, at the last meeting of the Regents before their memorial was sent to the legislature, asked them to incorporate in their memorial a request for \$2,000 to be expended in the work of the state Fish Commission, under the direction of some one of scientific training. The Fish Commission suggested that a part of the expense be borne by the University and that the University receive the collections made, for the museum. This request was not acted upon at the last meeting, but vesterday an appropriation of \$500 was made, \$200 of which is for the hire of a student assistant to go into the field during the summer and to work at the collections during the following academic year. Prof. Reighard will undertake the direction of this work without compensa-

The petition of the Athletic Association, made through the Advisory Board, of which Prof. de Pont is chairman, for an appropriation of \$5,500 to fit up the new grounds, was deferred until next meeting, when more accurate plans and estimates can be obtained. Pending the calling of the roll, D. If we want to get up a call for a citizens' mass meeting to name a ticket let's do it to-night. THE SECRET OF GOOD ROADS.

In the old world they know two things about roads and roadways with which the people of the United States are not generally familiar. They know how to they know how to care for it after it is built, which is another. We of America know more about building roads than we do about taking care of them. More read about the roadways of England, France or Germany, that have been in use for 100 or 150 years or more, we must not understand that there is a solution. Nothing could be further from the truth. All good roads are subject to constant attention, otherwise they are bad roads. maintain itself. This is where a great mistake is made in American roadways. Whatever may be said for our organization for building roads, little or nothing can be said with respect to our organization for caring for them. This is something we do not understand. We have I presume! been reaching for the impossible—the self sustaining, the self repairing, cheap roadway. It does not exist.

I have paid some little attention to the roads of Great Britain and France during the last few months, and what has impressed me more is the care exercised

I bear in mind a beautiful carriage drive through a part of Scotland. The roadbed was as solid and smooth as a concrete floor. There was not a suggestion of a rut or depression for miles. It followed the natural contour of the country, which was somewhat irregular, with its trim, neatly formed ditches and its spacious, substantial culverts where they were required. The smoothness I nursery maids." could hardly understand. It was certainly the perfect roadway. I looked for ruts or depressions, but there were none. Finally I came upon an old Scotchman with a wheelbarrow, a pick, a hammer, a pointed bar, other tools and some broken stone. He was getting ready to do some work. I stopped our horse, got Mr. Sweet, of Toledo, gave Milan out and examined the surface, but could see only a very slight depression. I asked the old man what he was going

to do, and he told me, in a Scotch dialect it, that he was going to cut out a bad place in the road and renew it. To see rain. what he would say I remarked that the place was not very bad, and he reminded me that a stitch in time saves nine. Then Dolly Smith, of County street, he went on to tell me that if a place was neglected it rapidly becomes very bad; that the wheel running into a slight depression would, because of the extra jar, make it speedily deeper and wider. There is no great expense in maintaining this perfect condition. The class of labor employed is cheap and the amount of surface inspected great.

Neglecting a good road like this would be like running expensive machinery without oil, which implies rapid destruction. Because of the well known result, the owner of the machinery cannot say oil costs too much money; we must get along without it. It is economical to do whatever is necessary to maintain a reasonably perfect condition. It is gross wastefulness and extravagance to do anything or to fail to do that which will cause general deterioration and in time large expenses. The cost of caring for a road is one of its fixed charges. If the road is allowed to decay it must be rebuilt. Hence the fixed charge represents the cost of a new road, or so much thereof as belongs to the replacing and renewal of material. On the other hand the constant attention which maintains a good condition at all times is also a fixed charge, and it will be found that within ten years the difference in the two costs will be largely in favor of the latter method, with the advantage of always having a good roadway rather than a decaying one.

Under the proper system of instruction and repair there is no reason why a road should not be better at the end of ten years than at the beginning. They see the little things which go to make the perfect travel, and they say that the very old highways which have the hundreds of years of history back of them are uniformly the best that they pass over. They account for this in the way I have named. The repairs which have been going on have added to the depth of the foundation and have made the entire passage uniform.

> Roadways should be considered in the nature of a business investment, and all calculations which are made with respect to them should be on a basis of a long term of years. It will be found that the cost of constant repairs under the system which I have suggested will be much less than the interest or added taxes, because of rebuilding or expensive repairs. It is a simple business matter and resolves itself into the question as



PROTECTION'S REDUCED AND STRIKES.

McKinleyism and Lower Wages-The New Tariff on Trial-A List of Wage Reductions-The Humbug Cry of Protec-

Protection is making a record for itself. A year ago the protected classes were flocking to Washington by the scores and hundreds to ask for higher protection. For whom? Not for themselves-oh, no!-for labor. The dear workingman must have higher wages; he must not be put on a level with the 'pauper labor of Europe." There were wonderful tales to tell about this same pauper labor.

One applicant for protection called foreign laborers "a set of men who have no sympathy with our social life, our traditions or our institutions." Another did not like Mexican labor, which he straightway named "peon labor;" another could not bear the thought of making American labor compete with the "horrid coolie labor of India." Still another described the labor of Bohemia in the terse phrase, "They are cattle;" and, finally, one manufacturer had heard something about German labor, and he 'did not want to see our well paid labor put on the same footing with those wuo

They were all certain that high duties would make them pay higher wages to their workingmen. Yet they asked for higher duties! McKinley took up their tale of woe and spoke in his report about "the poorly paid labor of Europe and cheap labor of Egypt and India."

In the coke region of Pennsylvania from 10 -000 to 16,000 men have been on strike since Feb. 9 against a proposed reduction of 10 per cent. in wages. Of the 16,000 ovens in this region, 10,000 are controlled by the H. C. Frick company, of which the well known high tariff advocate, Andr / Carnegie, is the head. The workmen mai tain that their wages should not be reduced, but on the other hand should be increased 12½ per cent., owing to the higher cost of living.

OF INTEREST TO APIARIANS.

Suggestions Made at a Recent Meeting of

Boston Bee Keepers. Mr. E. L. Pratt, of Beverly, read an interesting paper on honey producing. In this he considered the matter of getting bees started in the section-a troublesome experience with many bee keep-He said:

"One or two colonies as a rule get into the boxes at once and make a start before the others begin. In this case simply shift a row of started sections with a middle row of one not started, bees and all. Continue to do this until all have at least one row of started boxes. Another plan is to tier two cases of sections above the strongest colonies, leaving out the center row of boxes in each case, and hang a frame of brood in all stages in their places. Leave thus until a start is made, when a row of started boxes can be placed in the center of each case, bees and all. If they refuse to work after this it is very evident that they intend to swarm, when every effort should be made to encourage them to do so. Disturb them as little as possible, and feed a little during unpleasant weather. Adjust a trap to the entrance and prepare a new hive for each, with starters in the frames not over two inches wide."

Mr. Pratt cautioned against the hiving of swarms on full sheets of foundation or drawn comb. He advised when the swarm issues examining the trap for the "When found remove the trap and adjust it to the front of the new hive and place it close beside the parent colony. Leave it until the swarm returns, which it will do in a few minutes, hiving itself as nice as you please. After the swarm is nicely settled in and on the hive it can be placed where it is to stand permanently and the queen allowed to run in among the bees. It is safer to wait until quite late in the afternoon before the queen is released. The case of started sections should be removed from the old hive and placed on the swarm. If these bees do not show comb honey it is because there is no honey in the field. In a few days the parent colony will have become strong enough to take a

new case of sections. To guard against the after swarming Mr. Pratt's advice was to readjust the trap to the old colony, catch and kill the queens as fast as they come off with a swarm. Then the trap should be removed to allow the last young queen a wedding flight. If increase is not desired the new hive can be placed on the old stand, and all the remaining bees can be shaken off the combs in front of the new hive at the end of the eighth day. The brood remaining can be distributed among the weak colonies or tiered over some colony that can care for it.

Things Told by New York Dairymen. The importance of maintaining the fertility of the farms was pronounced at the late convention of the New York Dairymen's association as being the most important question before the dairymen. Mr. F. D. Curtis said: "We must engage in a mixed agriculture, not confining ourselves to one line. The silo is one means of getting out of the rut. So also is the raising of grain and feeding the same on the farm where it is raised. It takes more milk to make a pound of cheese or a pound of butter than it did twenty years ago, and this comes from the lessened fertility of our farms."

A. D. Boker, of Aurelius, favored dairying on a grain farm. He had found it an advantage to raise the grain consumed instead of buying it. He said: 'Any farmer who can raise corn cannot afford to do without a silo."

Secretary Woodward explained the cost of keeping cows out of doors as follows: 'It takes twenty-four pounds of hay to keep a cow twenty-four hours if she runs out of doors. If she is kept in all the time she can be kept up as well with eighteen pounds of hay.

# The Best Root for Farmers.

Among other practical questions answered at one of the State Farmers' institutes was the one, "What is the best root for farmers to grow?" This was answered by Mr. Curtis, of Saratoga county, who said:

The best root is the carrot, but the cheapest to produce is the turnip, and the progressive farmer must be its friend. Breeding sows can be wintered and do grandly on flat turnips and clover hay, nothing else. They will do The ribbon weavers of the Adelaide silk mill, better on other roots, but we can grow two crops on the same land on which the turnips are produced. For instance, one acre of good clover will furnish the hay for a score of hogs and the turnips also. People talk about a turnip flavor to milk and use milk with a manure flavor. There is too much senseless prejudice and notion about a great many things. Let us produce the foods which we can get the cheapest, and especially if they are healthful.

# What Others Say.

The amount of food that one horse may thrive and do well upon may injure another. It is as necessary to know the capacity of the horse, as far as his digestion is concerned, as it is to know his strength and how much he is able to pull.

Stoddard says: One should be somewhat sparing in the use of cooked food for the laying and the breeding stock, as it appears to favor the development of fat about the ovaries. In general onehalf of the food may be cooked, and in cold weather may be fed warm. Force pullets to lav with plenty of egg producing food, but not with stimulants.

Rooting grapevine branches, according to Popular Gardening, should be done in early spring. Dig a shallow trench into which the branch or stem is to be laid. Cover lightly, to keep in place. When the buds start into growth fill the soil back into the trench. With such treatment each shoot will be likely to produce a plant.

The ewes need a variety of food, and though they should not be fed too heavily just before lambing, for fear of makng them too fat, and thereby inducing milk fever, they should not be slighted after the lambs are dropped, for it will be all that the ewes can do to provide milk for strong, vigorous lambs.

About What Gov. Nicholls Says to Your Uncle Samuel.

WASHINGTON CITY, March 25. - After devoting about a week thereto Governor Nicholls, of Louisiana, has at last replied to Secretary Blaine's communication relative to the massacre of the eleven Italians in the New Orleans jail. After giving his interpretation of the secretary's communication at some length to the effect that the said communication meant to his room for several weeks past, and what it said, and reciting the substance of the telegram sent immediately in reply, the governor proceeds to intimate that it 38 is none of the federal government's business in the following terms: "A week has passed since the date of my dispatch, and the opinion then entertained as to the termination of the trouble has proved to have been well founded. The men killed, as I have stated, were confined in prison, under indictments found in the criminal district court for the parish of Orleans; the sheriff had made his return of the facts to that court; the judge thereof has charged the grand jury now in session in regard to the matter, and the whole subject is, I assume, now under investigation by that body. I am satisfied that most of the persons killed were American citizens, but it probable that two or three were Italian subjects."

Referred to Baron Fava. The letter is dated March 21, and from Baton Rouge, the state capital, but was evidently written at New Orleans, as the governor writes of "this" city instead of "that" city. Secretary Blaine sent to Baron Fava, the Italian minister, a copy of the letter. The next move must made by Baron Fava, as the United States is powerless to do anything in the matter while the action of the avengers is being investigated by the New Orleans more. grand jury. Delayed action or failure to hold any persons responsible for the killing may decide Baron Fava to take active means to bring about some settlement satisfactory to the Italian government. He will probably receive advices by cable within a day or two from Rome as to what course he shall pursue.

Meetings have been held in every city where the 'Mafia' enjoys a home and we have been found guilty and condemned to the final punishment that the Mafia may elect to impose. I have yet to hear of a single meeting of Americans to indorse the action of Americans in disposing of these horrid reptiles that curse our country. There is not a reputable Italian in this city who does not in-

His death was so peaceful that Gen. McLane, who was at his bedside, could not for a moment believe that the general was dead. There was not a sigh, not a movement; his heart ceased to beat, and he sank to rest as peaceably and as quietly as a babe to sleep. In addition to his heart trouble the general had contracted a severe cold, when he recently acted as pall bearer at the funerals of Admiral Porter and Gen. Sherman.

Brief Sketch of His Career.

Gen. Johnston was born near Farmville, Va., Feb. 3, 1509. He was graduated in the same class with Gen. R. E. Lee from West point in 1829, and ranked Lee at the outbreak of the war of the rebellion, being his senior as a general in the Confederate army. After the war he served in congress from the Richmond, Va., district, and was subsequently commissioner of railroads, being appointed by President Cleveland. With the death of Gen. Johnston there is removed the last prominent figure on either side in the great civil war. The funeral of Gen. APPALLING MORTALITY IN CHICAGO.

The Grip and Other Climatic Diseases

Killing People by Hundreds. CHICAGO, March 25.—The grip epidemic is unabated in this city and the mortality continues appalling. Up to mid-night vesterday the deaths for the week aggregated 1,540, or thirty-five per 1,000, which is unprecedented in the history of Chicago. Nearly all died from climatic complaints. Drug stores have been compelled to increase their force of clerks. Undertakers are crowded with work, and many funerals are taking place as early as 7 a. m. and as late as twilight.

Physicians and Nurses Succumb. Eight physicians of the German hos pital were taken down Monday, and seventy-two nurses of the Illinois Training School for Nurses, who have been ministering to the sick, have succumbed since Saturday, and some are in a critical condition. At the Women's and Children's hospital, out of a staff of forty physicians, nurses and attendants, all but five are unfit for duty. The physicians are in hopes that the disease will wear itself out, but all say that until there is a change in the weather no great improvement can be

expected.





The Matter To Be Investigated. Owen said yesterday that he never offered Wilcox \$30,000. "Wilcox," he said, gave me to understand that he was opposed to a gerrymandering scheme. All I said, as I recollect it, was that this was the chance of his life." Owen also stated that he had talked with a prominent Detroit Republican, Senator Joe Weiss, about the independent vote before approaching Wilcox. Weiss said last night that he had talked over the situation with Owen, but denied that there was any intimation that votes would be purchased. Repeating Telegrams.

Telegraph companies persistently print at the top of their message blanks a warning that they are not responsible for mistakes in transmission, and they also proffer, in very small type, the adalso proffer, in very small type, the advice that "to guard against mistakes or Beef dressed per cwt delays the sender of a message should Butter per th. order it repeated; that is, telegraphed back to the originating office for comparison," at an additional charge of onehalf the regular rate. The notice has steadily adorned the blanks in spite of court decisions that the companies are responsible for errors, whether the messages are repeated or not, and in spite of the additional fact that it is rarely read, or, if it is, the interest excited is only casual. Nobody ever seems to accept

the advice regarding repetition. An operator, speaking of the old notice recently, said that in an experience of fifteen years he had never seen but Wayne, is spending the week with one message bearing the order to repeat, and it was regarded as a great curiosity. This message fell a victim to excessive caution. It was bound from New York to San Francisco. It contained but one word, the little word "Yes." It was religiously repeated back from every relay station between the Atlantic and Pacific, but by some misfortune, due to a second of abstraction on the part of an operator, or to a timely but unfortunate "flip" of the instrument, the word was changed to "No." A big row ensued, and an operator in New York nearly lost his position.—New York Times.

Healthfulness of the Electric Light.

The healthfulness of the electric light was recently illustrated in a striking manner. Some railway men were discussing in a car factory the relative advantages of illumination by gas and electricity, and the advocates of each system remained unconvinced by the other. Finally the superintendent of the factory suggested that the matter could easily be put to a practical test, and turning on the gas in the smoking compartment of an adjacent car he invited the officials inside. It is said that their stay was of the briefest, for in a very few minutes even the strongest of them had to succumb to the heat and oppression and to seek the outer air.

A like test, made in a compartment lighted by incandescents, was attended by a very different result, and the verdict which followed was unanimous for the cool, wholesome light. This will readily be understood by those who, accustomed to the electric light, have occasion to sit in gaslit rooms in which the sense of heaviness often becomes oppressive.—New York Telegram.

Rags for Americans.

How our high tariff on wool operates toward forcing us to wear Europe's rags, old clothes and hair may be seen from a recent English letter in The American Wool Reporter. The writer, in giving the exports from London to American cities for the first week in February, notes that the shipments to Boston were 290,000 pounds of wool and 320 tons (716, 800 pounds) of rags, and that 1,000 bales of rags were in transit. To Philadelphia there were no exports "except 150 bales of cow hair in transit." To Baltimore there were 24 tons (53,760 pounds) of rags. From Liverpool to Philadelphia 134 bales of wool, 121 bales of goat hair and 116 bales of cow hair were exported.

If we had free wool there would be less occasion to buy Europe's rags to make shoddy clothes for so-called "free American citizens."


