The Question at What Date the New Tariff Went Into Effect.

WASHINGTON, Sept. 20 .- The question of the date upon which the new tariff law went into effect, involving the question of rebates on goods imported between Aug. I, the date fixed in the enacting clause and Aug. 23, the date when the bill became a law, which was raised by some of the New York Importers and is now under consideration by the New York board of general appraisers, has been referred, at the request of Appraiser Sommerville, to Solicitor of the Treasury Reeve by Assistant Secretary Curtis. Solicitor Reeve has carefully looked into

the precedents, and after a thorough examination has rendered a decision. Although the decision has not been made public it is understood that the solicitor holds that the law did not go into effect until it was officially promulgated by the state department Aug. 27. The importers will likely carry the question into the courts.

WHISKY TRUST CONDEMNED. Judge Gibbons at Chicago Says It Has' No Right of Existence.

CHICAGO, Sept. 2).-Ever since May 19, 1893, a fight has been going on in the courts here against the whisky trust, the fight having been inaugurated by Attorney General Moloney. The case has at last come to a head and Judge Gibbons has rendered a decision that disposes of it in the lower courts. The trust fought the case step by step, but all its pleas were overruled or otherwise rejected by the different courts.

The final decision declares that the concern is a trust, it matters not what name it goes by, or how it came into posession of the property it controls; it does con-trol eighty-one distilleries and is undoubtadly a trust that ought not to be tolerated. The judge said in the course of his decision: "Corporations may flourish and expand, but competition and individualism must neither be thwarte i nor crushed.'

Brotherhood of Locomotive Firemen. HARRISBURG, Pa., Sept. 20.—The matter that has been the one of calef interest in the convention of locomotive firemen has been decited, and Grand Master Sargent and Vice Grand Master Hannahan wili succeed themselves. It was conceded that Sargent would be almost impossible to beat, but there was a strong combination against Hannahan owing to his advice to firemen in the A. R. U. strike. About Aug. 1 all the elevator men signed an agreement with the board of trade promising to abide by the provisions of a formulated rule, by which the elevator men were to grant certain concessions and receive certain concessions from the board. An Ordinance Relative to the Licensing of Dogs, and Regulating the Running at Large and the Slaying of Dogs.

The Common Council of the City of Ann Ar

borer of any licensed female dog, knowingly to permit her to run at large while in heat, and it shall be the duty of the police of said city to seize, take up and deliver to the pound-keeper any such dog found running at large in said city at such time. It shall be the duty of the pound-master to serve upon the owner, or keeper of such dog a notice in writing of the impounding of such dog at once, and any such dog so impounded may be redeemed or taken from such pound by the owner or keeper of such dog within forty-

Section One of this ordinance, into the city treasury, and also to pay a fee of twenty-five cents to the clerk of said city for the issuing and recording such license: also to obtain the city clerk's receipt for said license so paid and the metallic plate or check hereinafter described, under the penalities herein provided.

Sec. 3. It shall be the duty of the clerk of said city to provide such number of metallic plates or checks as may be necessary, of such size and shape as he may deem expedient (the shape of such check or plate to be changed each year), having stamped thereon numbers indicating the year for which the tax is paid, the number of the license and the letters A. A. D. I., and to deliver one of these metallic plates to each person so paying license upon any such dog.

Sec. 4. It shall be the duty of such owner,

It shall be the duty of the poundmaster of said city to take up and impound any dog, male or female, found running at large, contrary to the provisions of this ordinance, in the city of Ann Arbor, not having a collar around its neck with the metallic plate or check aforesaid attached thereto, an, if said dog shall not be redeemed as hereinafter provided, within four days after such dog shall have been impounded, it shall be the duty of the poundmaster, at the poundmaster's fees, arising from such sales, shall be paid to the clip the sale in the sime; or if the animal is worthy and valuable, the same shall be sold by the poundmaster, at the poundmaster's fees, arising from such sales, shall be paid to the City Treasurer by the said poundmaster a receipt of the city clerk, showing that the license in this ordinance imposed has been paid for such dog, and the payment to said poundmaster and pounded. Sec. 6, it shall be the duty of the marshal and the further sum of twenty-five cents per day for each and every day such dog shall have been impounded.

Sec. 6. It shall be lawful for any person, and it shall be the duty of the marshal and each patrolman of the city of Ann Arbor, to seize, take up and deliver to the poundkeeper any dog, male or female, found running at large in said city in violation of any of the provisions of this ordinance.

Sec. 7. The poundmaster of said city is hereby authorized to collect the fees provided for in Section Five of this ordinance, for all dogs impounded, and he shall retain such, fees as compensation for his services as poundkeeper under this ordinance; provided, that when any dog which shall have been delivered to said poundmaster by some person other than the marshal or a patrolman of the city of Ann Arbor, shall have been redeemed in accordance with the provisions of Section Five of this ordinance, one-half of such redeemption fee shall by said poundmaster bapaid to the person who delivered said dog to the poundmaster as provided in Section Six.

Sec. 8. It shall not be lawful for any owner possessor or person having in charge or care, a fierce or dangerous dog, to permit or allow the same to go at large at any time in said city, to the danger or annoyance of any of its inhabitants. Whenever any person shall have been convicted of violating the provisions of this section of this ordinance, and shall permit or allow such dog to run at large after such conviction, it shall be duty of the police authorities of said city to kill such dog. Sec. 9. It shall be unlawful for the owner, possessor, keeper or harborer of any licensed female dog, knowingly to permit her to run at large while in heat, and it shall be duty of the police anthorities of said city at such time. It shall be the duty of the pound-master to serve upon the owner or keeper of such dog within forty-eight hours after service upon such owner or keeper of any such dog so impounded may be redeemed or taken from such

noon next succeeding the expiration of said forty-eight hours.
Sec. 10. It shall be unlawful for any person to own, keep or harbor any dog, which, by loud and frequent barking, howling or yelping, shall cause serious annoyance or disturbance to any of the citizens of said city.
Sec. 11. Whenever any danger shall be justly feared as likely to result from hydrophobia, the mayor shall publish his proclamation requiring all persons owning or having in charge or keeping any dog or dogs, to confine them on their premises for a prescribed

Sec. 12. Whenever any person shall have been convicted of owning, possessing, keeping or harboring any dog that has bitten any person within said city while peaceably walking or riding without the enclosure of such owner, keeper or harborer of sald dog to kill the same within six hours after service on him of such order. The owner, possessor, keeper or person having in charge any such dog, who shall refuse or neglect to kill it within six hours after having received such order, shall on conviction before the proper tribunal, be liable to the punishment provided in section Thirteen of this ordinance, and it shall be the duty of any police officer to destroy such dog whenever he shall be found at large in said city six hours after service of said order.

Sec. 13. ### A WOOLLY ASSERTION.

The wool growers of Ohio met in convention at Columbus, recently, and issued an appeal to the people. In this appeal the following assertion is used: "Full and adequate protection for the wool industry would soon increase our 45,000,000 sheep to a required 110,000,000, furnishing 650,000,000 pounds of wool annually-all needed-and we would import none."

Let this assertion be examined in the light of past experience for its value as a guide for the future.

Since 1816, a period of seventyeight years, wool has never been without protection, until it was placed on the free list by the present law. If, therefore, "full and adequate" protection has anything to do in increasing the number of American sheep and bringing the domestic wool clip near to the total amount consumed, some progress should have been made in the period named. What are the facts?

In 1840, the official statistics show that the proportion of foreign wool in our total consumption was 21.5 per cent. In 1850 this had increased to 26.3 per cent; in 1860, to 30.6 per cent; in 1864, to 42.6 per cent. In 1868 it dropped to 11.9 per cent, again increasing in 1872 to 45.3 per cent. In 1890 it was 27 per cent; in 1891, 30.8 per cent; and in 1892, 33.1 per cent.

These figures do not seem to lend Ohio wool growers. They show that under the McKinley act which was the ideal "full and adequate" protective tariff of these wool growers, since its schedules were dictated by them, the percentage of foreign wools consumed was larger than under the tariffs of 1840, 1850, 1860, and at different periods under the Morrill tariff and greater also than neighbor. Clever Japanese Devices

The Japanese have a mode of preparing stencils which is better than ours. In our method complicated figures must be divided by broad lines of paper in order to glue the paper together and make the stencil strong enough for use, and these bands of paper leave blanks in the design which must often be filled in by hand. The Japanese cut their stencils out of two or sometimes three thicknesses of thin but tough paper. Then between each two of these sheets they lay, crossing one another in all directions, human hairs or fibers of raw silk. These are specially laid across the several layers of the stencil are glued together they serve the same purpose as the bands of paper left by our stencil cutters, but they form no obstacle to the application of the color and leave no blanks in the design.

When the heat of a tropical or semitropical summer dries up every pool and parches the ground to such an extent that it is difficult for animals not endowed with great powers of locomotion to obtain water, they compromise with nature by sleeping off the season of heat and scarcity. The winter sleepers are all pretty well known; but, owing to the summer sleepers being for the most part inhabitants of tropical countries, far removed from the path of trained observers, we are less acquainted with the species practicing that means of escaping the heat and drought of summer. Indeed at present only one mammal, the tenec, a hedgehoglike beast of Madagascar, is known to do so. In South America and Africa various reptiles estivate. In the plains of Venezuela the alligator, the land and fresh water tortoise, the boa constrictor and several sorts of the smaller kinds of serpent lie motionless during the hottest period of the tropical summer. But their dormancy is not so perfect as that of some hibernators. 

CAN A HEALTHY PERSON PROLONG HIS LIFE TO 200 YEARS?

The Theory of "Retarding Vital Consumption"-Franklin and the Flies-Work the Heart Does-Recent Experiment In the Partial Vegetarian System.

Among the various fantastic theories for prolonging life one of the most popular at the end of the eighteenth century was what was called "retarding vital consumption." Maupertuis fancied that a complete suspension of vital activity. a sort of Rip Van Winkle sleep, might be produced so as to check self consump tion. Bodies in this state could be laid away and then resuscitated after a lapse of two or three centuries Benjamin Franklin even, while living in France, seems to have had faith in this. One day he received some bottles of wine from Virginia. In one of them-only one-were a few dead flies, which the great philosopher resolved to utilize in an experiment. The month was July, and these imported flies, which had been on a spree in Virginia, had fallen into the native wine and had been in this state shipped to France, where they were exposed to the heat of the French sun. Three hours passed, and the winged Virginians came to life after an apparent death of many weeks. At first a sort of convulsive movement seized them. They began then to use their legs, walked around awhile, and seeming to be aware that they were in France immediately concluded to make their toilet by rubbing their eyes with their fore feet, using their hind legs to smooth out their wings. They then flew away to associate with Paris flies. Franklin wrote of the incident:

"Since by such a complete suspension of all internal as well as external consumption it is possible to produce a pause of life and at the same time to preserve the vital principle, might not such a process be employed in regard to man? I can imagine no greater pleasure than to cause myself to be immersed, along with a few good friends, in wine and to be again called back to life at the end of 50 or more years by the genial solar rays of my native country, only that I may see what improvement the state has made and what changes time has brought with it."

It was once thought that people died from lack of what physicians called "the vital principle." It is a phrase that has a fine, vague, mysterious sound, but it really means little or nothing. Or, in other words, it is now conceded that death comes from disintegration, very gradual often, it is true, in all the bodily organs, brought about by the all important blood being blocked up by accretions which close the channels leading from the heart. Most magnificent and most wonderful muscle as the human heart is, it may get clogged in such a way by the earthy salts in the blood as to be unable to perform its regular functions. Then the life fluid can not be kept in proper circulation Allowing 69 or 70 pulsations of the heart -the usual average-every minute, one person has 100,000 heart beats in the space of one day. This means, of course, that the heart and arteries are contracted with such power as to keep 50 or 60 pounds of blood in healthy movement. Washington, Sept. 20.-In compliance with a resolution of the senate, introduced by Senator Pettigrew, the interstate commerce commission has compiled some data regarding the ownership of railroads by foreign governments. This is summarized as follows: "Is appears that ten countries do not own or operate railways, viz: Columbia, Great Britain and Ireland, Mexico, Paraguay, Peru, Spain, Switzerland, Turkey, United States and Uruguay. The following governments own and operate some of the railways: Argentina, Australasia, Austria-Hungary, Belgium, Brazil, Canada, Cape of Good Hope, Chili, Denmark, France, Germany, Guatemala, India, Japan, Norway, Portugal, Russia and Sweden-eighteen.

Americans Travel the Cheapest. "The following governments own part of their railways, but do not operate any, leasing all the present mileage to private companies, viz: Greece, Holland, and Italy -three. Though not claimed to be ac curate, it is believed that the foregoing summary represents an approximately correct statement of the relation of the various governments to the railways of the world." A comparison of passenger charges per mile shows an average in Great Britain of 4.43 cents for first class, 3.20 cents for second class, and 1.94 for third class. In Figure the average is 3.86 cents for first class, 286 cents for second class and 2.08 cents for third class. In Germany the rate is 3.10 cents first class, 2.33 cents second class, and 1.54 cents third class. In the United States the average charge is

The System Extant in Austria. The system of operation of the railroads in different countries is indicated: In Austria about 4 per cent. of the railway mileage is owned and about 73 per cent. is operated by the state. Upon the expiration of charters, not exceeding ninety years, the lines, lands and buildings of the companies are turned over to the govern ment, but the equipment remains the property of the private owners. Before a ranway is opened it must be approved by the minister of commerce. The tariffs of state roads are fixed by the government; those of the companies are subject to revision by the government every three years, and the government has power to reduce rates if the net earnings exceed 15 per cent. on capital.

# CANADA'S RAILWAY SYSTEM.

She Owns One-Tenth Thereof-Loss of \$600,000 in One Year-French Roads.

In Canada about one-tenth of the mileage of about 15,000 miles is owned and controlled and operated by the government. For the year 1892 the operation of the government lines resulted in a loss by private companies, each company serv ing a definite territory and being comparatively free from the competition of other lines. But the railroad properties are

required to manage the railways in the interest of general traffic on a single systraffic and police regulations. In Great Britain and Ireland the government does not own the railways. There are stringent regulations provided by law and administered by the railway commission and board

of trade. Italy has tried both state and private railroads, and has come to the conclusion that it is not advantageous to own and operate the railways. The result was a reorganization of the whole railway systems. Under the present system private companies operate the state roads under contract with the government. In Russia the government is stated to own and operate about 40 per cent, of the railway by private companies have received subsihes from the government.

It is stated that in the United States several of the states have tried ownership in a limited way. Illinois constructed road at a cost of \$1,000,000, but disposed of it for \$100,000. Indiana had a similar experience; Georgia owns a railroad, but found it expedient to lease it to a private company; Pennsylvania constructed a railroad from Poiladelphia to Columbia, but subsequently sold it; Massachusetts, Michigan and several other states tried the experiment without success.

The inter-state commerce commission disclaims any original investigation on subject, the report being compiled from existing sources of information.

The platform in-dorses the Ocala platform, as well as the Chicago platform; demands the free coinage of silver at a ratio of 16 to 1, and indorses the dispensary law as the best solution of the liquor question.

An attempt to denounce President Cleve-

land was killed and no mention of the administration appears in the platform. The Charleston delegation tried hard to get the convention to come out squarely on the Democratic platform and denounce Populism, but the effort was defeated by an overwhelming vote. The convention then nominated John Gary Evans for gov-ernor; W. T. C. Bates, treasurer, and O. W. Buchanan, attorney general. The nominees are all Tillmanites. The Charleston delegates announced in the convention that they would not support the nominees.

The anti-Tillman committee in view of the fact that the convention failed to unequivocally denounce Populism, has called their convention to reassemble in this city on the 25th inst. for the purpose of placing a ticket in opposition to the one just nominated.


