

The finding of the jury in the case of L. D. Godfrey was such as to associate Mr. Bower with the cause that led to Mr. Godfrey's death. Under the circumstances we desire to notify you on behalf of Mr. Bower that he is prepared to justify his course in the lamentable affair; and we further desire that, if, after hearing all the testimony in the case taken at the inquest with care and minuteness, you purpose directing a complaint to be instituted, it should be instituted without delay. Oats. - Early sown oats in our hot climate are, as a rule, better than the late sown. Our climate is not so favorable for oats as tye cooler northern and northeast-There oats are heavy and plump, and seed from Canada, Nova Scotia, and New Brunswick will produce well for two or three years. By using seed from these northern localities, oats may be grown in healed more frightful wounds, and saved the Middle States weighing from 35 to 45 pounds per bushel.

Success With Peaches.

All who have grown the peach know that as the tree gets old the fruit grows or headed in, and well fed with manure, the fruit will hold its large size on old trees—that is, if grubs are kept out by a free application of wood ashes to the roots, and a coat or two of whitewash (with car-bolic acid mixed in) put on body and limbs. Our experiment was to cut limbs off from old trees that were breaking down with age, and that were yielding very small fruit. We threw around under the tree plenty of manure and worked up the soil, and this year the new growth had a load of large, luscious peaches. "Peaches are short-lived," is a common remark. So would you be if you were used and treated as are peach trees. Keep the grubs out, feed them yearly with manure, ashes, and salt, and keep them well headed in, and you will get peaches of large size for years,


