A premature explosion of a blast occur-A joint resolution has been introduced in the senate proposing an amendment to the constitution providing for the election of senators for a term of four years, and requiring that but sixteen of these be elected at every alternate election of a state legislature. The resolution seems to conflict with section one of article four of the constitution, and has been referred to the judiciary committee.

In executive session the other day the In executive session the other day the senate condirmed the nominations of Dr. Hal C. Wyman of Detroit, to be a member of the state board of charities and correc-tions; Sidney D. Miller, to be member of the board of metropolitan police commis-sioners for the city of Detroit, and Wm. Ball to be member of the board of control of the state reform school.

A bill of considerable importance has been introduced in the house by Repre-sentative Cross of Van Buren county rela-tive to the disposition of state part paid swamp lands. The measure provides that township boards may make compromise settlements and determine thereby the sum which the commissioners of the state land office may receive in extinguishment of the ditch, or drain or other taxes charged against these swamp lands in their several townships, and that this sum, when so determined, shall be received in lieu of all the taxes above described and interest theron. The passage of the meas-ure will be of particular advantage to many of the township school funds.
