





The total vote received by governor Rich this year was 237,215, an increase of 15,087 over his vote in 1892. Fisher's vote of 130,823 this year was 74,405 less than were cast for Judge Morse, who was the Democratic candidate two years ago. The Populist vote increased 8,585 over 1892, and the Prohibition vote decreased 1,989. Gov. Rich had a plurality of 106,392 and a clear majority over all of 57,605.

EVENTS OF GENERAL INTEREST AND IMPORTANCE.

Some Interesting Gossip of the Oriental War.-Debs and His Associates of the A. R. U. Sentenced to Jail .- Another

Big Oil Trust Organized.

News From the China-Japan War. Shanghai: It is stated that the Japanese have effected a landing at Shan-Hai-Kwan and near Taku. The Japanese are said to number about 25,000 men. Large numbers of Tonghaks in southern Korea made an attack upon Koshin, and were defeated by the Japanese with great slaughter. Two of the rebel chiefs were killed.

Yokohama: A detachment of the second Japanese army have occupied Fuchow, a town some 75 miles north of Port Arthur. They met with no resistance. The Chinese are retreating in a northeasterly direction towards

London: A Shanghai dispatch says that the Chinese soldiers at Wei Hai Wei intend to desert if the Japanese appear. The Times publishes a dispatch from Kobe, Japan, stating that it is supposed that the first and second Japanese armies will join forces and take Kor Chang and then make a combined advance on Pekin. Further re-inforcement will leave Hiroshima for the front within a few days. The posi-tion of fit Hung Chang at Tien 1sin is established on a firmer basis than ever. Even the empress dowager has given him emphatic assurance of her confi-dence. After trying various alterna-tives, the court finds that Viceroy Li Hung Chang is indispensable, as he is the only capable man, the others having proved to be useless.

UNITED STATES AND SPAIN

At Sword's Points on Tariff Matters-Uncle Sam Getting Red Hot.

Spain has for years been a source of diplomatic trouble to the United States. She has at times placed the most outrageous tariffs and excessive fines upon American exporters and steamers, and although in most cases Spain has been forced to acknowledge herself in the wrong restitution could not be secured. Fully \$5,000,000 in claims are now standing against Spain and she will not even submit to arbi-

The passage of the Wilson tariff bill carried with it the repeal of all reciprocity treaties, and Spain, to retaliate, has placed in force in her West Indies possessions a tariff against United States products which is utterly woblistics. Provident Cleveland has prohibitive. President Cleveland has tried in almost every diplomatic way to have it removed but without avail, and now, becoming tired of such stub-bornness, he has decided to place a probornness, he has decided to place a pro-hibitive duty on Cuban sugar. Our principal product exported to Cuba is flour and in the year 1893 our exports of this staple to Cuba alone were valued at nearly \$3,250,000. On the other hand, during the same year, we bought about \$64,000,000 worth of sugar of that island. This action by the President is equiv-

alent to a formal notice to the nations of the earth that if trade discrimina-tions against the United States do not cease measures will be adopted by the President for the protection of American commerce. As has been said, one of the chief offenders is Spain, and for that reason Medical is collected as that reason Madrid is selected as a point of attack, though the action be rightfully construed as indicating a policy applicable to Germany, Denmark, France and many other nations that have put an embargo on certain American products.

Debs et al. Guilty and Sentenced. "Guilty as charged," was the finding announced by U. S. Judge Woods at Chicago, against President Eugene F. Chicago, against President Eugene r. Debs and other leaders of the American Railway Union in the great railroad strike of last summer. The decision was a very long one. Much of it was devoted to showing that the United States had authority to intervene in order to abate a public nuisance, which affected the whole nation, and that the United States had a right to that the United States had a right to stop unlawful interference with the passage of United States mails and interstate commerce. When the judge was ready to pronounce sentence none of the defendants had anything to say. Judge Woods then sentenced Vice-President Howard, Secretary Keliher, Treasurer Rogers and Directors Burns, Elliott, Hogan, Goodwin and Maevean each to three months' imprisonment in jail, but suspended sentence on the last named director. President Debs was given six months. It was evident that all had expected much more severe sentences, and they seemed well pleased. A stay of sentence for 10 days was granted to permit of an appeal. There were two cases before the court, one for contempt and the other for violation of the federal statutes. The sentences were the same in both cases but they run together and are not cumulation.

Japs Deny Bloo Ithirsty Charges. Washington: Advices from Tokio are to the effect that the stories of murderous atrocities at Port Arthur by the Japs are exaggerated. A num-ber of Chinese soldiers, disguised as citizens, it is said, attacked the Japs, and were killed. Some citizens may have been killed by mistake for soldiers. Some groups of Chinese who were found with the mutilated corpses of Japanese prisoners were also killed by the enraged soldiers of the mikado.

Judge Jenkins has issued an order prohibiting the garnisheeing of the wages of an employe of the Northern Pacific railroad during the life of the receivership.

FAMOUS NOVELIST DEAD.

Robert Louis Stevenson, Author of "Dr. Jekyll and Mr. Hyde," Died at Samoa. Advices from Apia, Samoa, are to the effect that the well-known novelist, Robert Louis Stevenson, died suddenly

from apoplexy. His remains were interred on the summit of Pala mountain, 1,300 feet high.

Robert Louis Balfour Stevenson was born in Edinburgh, November 13, 1850. One of his earliest works was an account of his travels in California, but the work which established his reputa-tion as a writer of fiction was "Treasure Island," published in 1883. Among the most popular of his works is "Dr. Jekyll and Mr. Hyde." Some time ago Mr. Stevenson, who was suffering from lung trouble, went to the South Pacific for his health. He became enraptured with the Samoan islands, and decided to take up his residence there. He took a close interest in Samoan affairs.

Almost the Entire Family Exterminated. Mrs. Winslow Shearman and her daughter, Mrs. Clinton Davis, who lived on a farm near Jamestown, N. Y., were murdered by unknown persons. Mrs. Shearman's husband had gone to attend the funeral of his son and daughter-in-law, Mr. and Mrs. Myron C. Shearman, who were killed by a He returned home about o'clock and was horrified to find his wife and daughter lying dead in the house. There is no clue to the perpetrator of the crime, although it is apparent that the motive was robbery. Mr. Shearman has lost his reason.

Another Prize Fighter Killed. George (Kid) Lavigne, of Saginaw, and Andy Bowen, of New Orleans, met orleans, to fight for \$3,000 a side. The contest was a hot one, the Michigan man had the best of it all along, and in the eighteenth round knocked Bowen out. Notwithstanding efforts to revive him, Bowen continued in an insensible state, and was finally taken to his home, where he died the next morning.

Cleveland Man Killed by Burglars.

William H. Price, a prominent business man and a member of the firm of Chandler & Price, of Cleveland, was murdered by burglars who were discovered in the house by Mr. Price. He heard a noise and proceeded to investigate gate when one of the robbers fired. The shot took effect in Mr. Price's breast and he only lived a few minutes. The burglars escaped.



ONE of the Detroit daily papers takes the Reform League to task about its statement that more drinking and smoking is done by the upper classmen than by the lower Possibly the Detroit paper is right, and, possibly too, there is a different explanation for this than the one given by the Detroit paper. It states that when the drinking freshmen and sophomores reach the higher classes and become more mature, they, of their own accord, give up the drink habit. That may have been true both before and since the latter half of the eighties, when the writer was in college. It certainly was not true from 1884 to 1888. We believe, however, that both the Detroit paper, and the Reform League are in error in this matter. We believe that there is more drinking and carousing among the lower classmen than among the upper classmen. In this respect we believe that the League is mistaken. On the other hand we do not believe that such students reform when they become seniors. The real explanation is that precious few of those who patronize the saloons, while they are lower classmen, ever become upper classmen. It is such young men who drop out of school at the end of the first or second year simply because they lose the inclination and capacity for doing University work while indulging in such habits.

Then, too, I see several of the professors in the high school smoking daily, and nearly all the professors in the University indulge in this habit. They are all men of great ability, ambitious to excel as students and teachers. They must know all about the effects of the use of tobacco and certainly would not use it if it was injurious. Then, too, they all claim to be high-toned Christian gentlemen, and they certainly would not set an example that would tend at all to injure the students under their charge, or others who might come within range of their influence.

F. I can hardly believe that the people of the state would employ instructors for the youth, who would by their example, thus lead the students under their charge, into forming habits of this character, but such seems plainly to be the fact. I now very readily see John that home influence and example can and does have but little weight in this atmosphere and in the presence of such examples as these you have mentioned. There is no course left for me but to take you home, John, and keep you in some business immediately under home influences, until you become so firmly established that such examples would not lead you astray. I regret to have you give up your school and college course, but if we must have the tobacco habit with intellectual culture, then I don't hesitate to abandon the intellectual culture, and I am sure the majority of the people of the state are of the same opinion.



### STATE NEWS NOTES.

A CHAPTER OF THE DOINGS OF MICHIGANDERS.

The Michigan State Grange Convention .-Population of the State by Census of '94 -U. S. Marshals and County Officers at Dagger Points at Allegan.

The State Grange. The twenty-second annual meeting of the State Grange was held at Lan-sing. Worthy Master George B. Horton looke I upon the agricultural conditions as unpromising and said the problem must be studied of bringing the expenses of government and home down to a level to the ability of the masses to pay. County granges were advised and joint action with other northwestern state granges in the form of a pool to secure trade contracts with manufacturers and bring them nearer the consumer. More stringent pure food laws were demanded and grange mutual fire insurance com-panies urged. He claimed that agricultural interests had been neglected in matters of legislation and farm pro-ducts and farm lands had declined ruinously. A revision of the tax laws was declared to be necessary, as farm lands pay a far greater rate in proportion to their earning capacity than money or corporate property. The ladies of the grange held a public re-ception in the executive parlors. The grange has 11,000 members in Michi-

Michigan's Population.

Secretary of State Washington Gardner has issued an interesting bulletin of the population of Michigan according to the state census of last June. The state has 2,211,454 inhabitants, an increase since 1890 of 147,565. The increase of population since 1890 in 61 cities of the state was 11.93 per cent, while outside of these cities the increase was 4.54 per cent. There are now 70 incorporated cities in Michigan with a total population of 821,032, or 37 per cent of the total population of

the state.

Not counting Isle Royal, which is attached to Houghton for judicial purposes, the present census shows 20 counties in the state with less population than in 1890.

Of the total population of the incorporated cities of the state, 551,365, or 67.16 per cent, are native and 269,667, or 32.84 per cent foreign born. The proportion of native to foreign born population in the incorporated cities is gradually increasing. Approximately more than five-eighths of the native inhabitants in the state live in the country, and less than three-eighths in the cities, while of the foreign birth nearly five-eighths live in the cities and three-eighths in the country. The total population of the incorporated villages in the state is 260,145, of which 211,506 are native.

HERE'S RARE FUN.

Uncle Sam's Officials and Allegan County Sheriff's Force in a Hot Fight.

Deputy U. S. Marshal O'Donnell, of Grand Rapids, arrested Deputy Sheriffs Ezra Town and Wilfred Roselle, of Allegan county, for selling liquor without a government license. They were brought before U. S. Commissioner Thew and they were acquitted. Before O'Donnell could leave the court room several deputies jumped upon him and arrested him on the charge of false imprisonment. O'Donnell gave them a stiff fight before he was handcuffed. The crowd thought there was going to be a shooting affair and piled

out of the room in a panic.
O'Donnell was released on \$1,000 bail and the next day U. S. Marshal Pratt. with two deputies arrested Sheriff Stratton and Deputies Wing, Roselle, Brown, Jones, Stockdale and Nash, all of Allegan county, for interfering with U. S. officer in the discharge of his duty. They were taken to Grand Rapids and after a preliminary hearing were released on bail.

Bent His Wife to Death, Then Suicided. The most bloody crime in the history of Manistee occurred when Casmir Herner murdered his wife by pound-ing and choking her to death. He dressed himself in his best suit of clothes, put on his regalia and read his Bible as it lay open before him on a brilliantly lighted table of candles. With his beads in one hand and a 32-calibre revolver in the other, he shot himself through the right temple. He never moved from his chair. It is supposed that in a fit of anger he killed his wife, as they did not live happily. He tried to roison not live happily. He tried to poison her twice before.

Big K. T. Reception to M. E. G. M. McCurdy Knights Templar of Detroit com-mandery may well be proud of the reception that they tendered to the chief of all Knights Templar of the United States, Most Eminent Grand Master McCurdy, of Corunna, and Right Eminent Commander of Michi-gan Charles H. Pomeroy, of Saginaw, at Detroit. At least 1,000 persons took part in the affair and it was a success from every standpoint. Many of the most prominent and best known men of Detroit and the state were present. The armory of the Light Infantry was never more beautifully decorated.

Stanley Barnard, a traveling man, while hunting at Flushing, accident-ally shot himself in the right hand and arm, which he is liable to lose.

### CONGRESSIONAL NEWS.

SENATE.—Eighth day.—The consideration of the Nicaragua canal bill was continued. Senator Dolph made a long speech in favor of the bill, in the course of which he advocated the abrogation of the Clayton-Bulker treaty. The venerable senator from Vermont Mr. Morrilli made some remarks, in which he criticised the currency inflation bills reported adversely from the finance committee. The day closed with an executive session in which a large number of nominations were confirmed. House,—The struggle over the bill to authorize railroad pooling terminated by the passage of the bill by a vote of 165 to 116. The Cooper substitute, which placed the entire control of the conditions of pooling in the hands of the interstate commerce commission and gave the absolute power in the matter of revoking pooling orders was defeated as were all subsequent efforts to amend and commit it, and the bill passed as reported from the committee.

SENATE,—Ninth day.—Senator Gray made

SENATE.—Ninth day.—Senator Gray made an unsuccessful attempt to have considered SENATE.—Night day.—Senator Gray made an unsuccessful attempt to have considered the bill reported from the finance committee striking out all the differential duty in favor of refined sugar and leaving all sugar dutiable at 40 per cent ad valorem. The majority vote of 10 against taking up the closure resolution indicates, it is believed, the improbability of changing the rules at this session. Mr. Morgan again spoke on the Nicaraguan bill and in concluding expressed his intention of soon asking that unsulmous consent be given fixing a time for a vote on the bill. Howse,—The first test vote on the income tax came in the committee of the whole in the House. Mr. Bartlett, (Dem. N. Y.) who is leading the fight for the abolition of the income tax, moved to strike out of the wrigen deficiency bill the appropriation which would make the collection of the tax possible, and his motion was beaten nearly four to one. The item for the appropriation of \$250.001 for the expenses of special examiners of the pension office brought forth considerable warm talk. Mr. Sickles (Dem. N. Y.) amid a roar of Kepublican applause repudiated the charge of wholesale fraud made by the administration against pensioners, and declared his unalterable opposition to the appropriation unless it could be authoritatively shown that the pension examiners provided for by it were employed in aiding instead of embarrassing deserving claimants. Mr. Henderson, (Rep. Ia.) inoved to reduce the appropriation to \$125.000, but the committee arose without acting. Thursday, December 20, was set aside for exercises in connection with the declication of the statues of John Stark and Daniel Webster.

SENATE.—Tenth day.—The day was consumed in the discussion of the bill to establish a national university at Washington and the Nicaraguan canal bill. Senators Hunton, of Virginia, and Vilas, of Wisconain, addressed the Senate in support of the former, and Mr. Morgan practically concluded his speech on the latter. He asked that unanimous consent be given fixing a time for a vote on the bill, but this was refused. House,—The House promptly went into committee of the whole and continued the consideration of the urgent dedelency appropriation bill. The pending amendment was that of Mr. Henderson (Rep., Ia., to reduce the appropriation of 250,000 for special pension examiners to \$125,000. It was lost. The committee then rose and reported the bill to the House with a favorable recommendation. The previous question was ordered and Mr. Cockran (Dem., N. Y.) moved to recommit the bill with instructions to strike out the appropriation for the collection of the income tax. Mr. Cockran is motion was defeated. appropriation for the general army service men at West Peint, \$46,63, provoked some discus-sion, but the bill was passed without amend-ment, and then the House adjourned.

Eleventh day.—No session of the Senate. HOUSE.—The time was consumed with debate House.—The time was consumed with debate on the pension appropriation bill, which was passed without amendment. During the debate upon it Mr. Sickels (Dem., N. Y...) expressed his disgust with the frequent recurrence in the president's message and in the report of the interior and commissioner of pensions, of charges of fraud in the pension roll. For the last time probably before his retirement from Congress, he said, he desired to defend his old comrades from this slander. The Hitt resolution of inquiry calling on the secretary of state for the correspondence relating to the payment of \$425,000, to the bill in connection with the fur seal controversy, was adopted. The evening session was devoted to the consideration of private pension bills.

SENATE.—Thirteenth day—The Nicaragna canal bill occupied the larger portion of the day, and three Senators made speeches. Mr. Peffer (Pop., Kan.) favored the measure under certain conditions, but was opposed to issuing bonds payable in gold to raise the money required. Mr. Squire (Rep., Wash.) declared unequivocally in favor of the construction of the canal, while Mr. Turple (Dem., Ind.), though approving a canal, expressed his decided opposition to the pending bill. Senator MeMillan introduced a bill authorizing the secretary of war to loan to the several states Springfield rifes in such quantities as may be desired by the state troops. Senators Quay and Cameron, of Ponnsylvania, presented voluminous petitions from citizens of Pennsylvania urging the passage of the pending bill restrictive immigration by excluding anarchists and other undesirable applicants for admission, and establishing a consular inspection abroad. House.—Mr. Herman (Rep., Ore.) presented a preamble and resolution declaring that the Chayton-Bulwer treaty was an obstacle to the construction of an inter-occanic canal, and that it should be abrogated. Mr. McRae, chairman of the committee on public lands, moved to pass, under a suspension of the rules, the bill to protect public forest reservations; passed. Mr. Outhwaite, chairman of the military affairs committee, called up the army appropriation bill and explained its provisions. The bill carried \$28,599,509,519,646 less than the appropriation for the current facal year and \$1,305,874 less than the estimates. Mr. Harmer, of Fennsylvania, introduced a resolution authorizing the President and secretary of state to use their good offices toward the reconvening of the powers signing the Berlin agreement of 1878, whereby joint protection was assured the Armenians as agrainst the Circassians and Kurds of Turkey. Mr. Outhwaite introduced a bill reviving the grade of licuterant-general of the army. Also a bill appropriation go for the statue of U. In a large number of manufacturing concerns in Massachusetts, the affairs of which are covered by the latest report of the state bureau of labor statistics, there were 43,803 partners or stockholders in 1893, against 42,735 in 1899. The number of males included in the total for the latter year was greater, however, than that which was covered by the larger figures for 1893. There were 27,325 male partners or stockholders in 1892, and 27,211 in 1893. On the other hand, the number of women who had an interest in the manufactories dealt with by the report was 16,592 in 1983 against 15,410 in the year preceding. 





LIFE OF OCEAN CABLES.

Some of the Oldest Submarine News Con-

ductors Still in Active Use. Noteworthy advances are being made in the art of submarine cabling, and some of the new cables are beautiful productions of modern ingenuity; but it is encouraging for those who have invested their money in ocean telegraphy to know that a very large proportion of the oldest cable still remains in active service. The primeval cables break once in a while, a repairing fleet is necessary, and an occasional new link needs insertion, but by dint of watching and patching the old cable enables the reserve funds laid aside for their renewal to take on such gratifying proportions that the stockholders could almost draw incomes from them alone. The latest Atlantic cables are distinctive chiefly for their greater weight of cop, or and dielectric and for the gre er speed possible in transmission. One of them, with 500 pounds of copper per mile, gives a speed of forty words per minute easily, while the other, with 600 pounds, is said to be capable of fifty words. In the old days 400 pounds was good enough, and it remains to be seen whether this will not suffice for the deep waters of the Pacific. Cables have been laid in 2,800 fathoms, but in the Pacific 4,400 is figured Alexander Siemens, the distinguished young president of the English institute of electrical engineers, says that he knows the bottom of the Pacific as well as he does his own bedroom, owing to the method of sounding employed by his staff when cable-laying; but there is a trifle of hyperbole in the statement, and a few more investigations are needed, especially around the Friendly islands and New Zealand, where depths of 4,000 fathoms appear to exist, and where cables lighter than the Atlantic types would probably have to be resorted to.

THE LARGEST HOSPITAL.

Four Thousand Beds Are Constantly Occupied by Patients.

What is doubtless the largest hospital benevolent and free school combined is in Turin, Italy. It is called the Cottolengo, and is three stories high in the form of a St. Andrew's cross It has 5,000 beds, over 4,000 being constantly occupied.

The connecting wing, forming the street front, contains the operating, waiting and other rooms. Numerous pavilions, cottages, school houses and workshops occupy the grounds, separated by small but well kept gardens and yards, giving plenty of air and light and adding cheerfulness to the conglomerate of stone structures. The whole being scrupulously clean, a pleasing, homelike effect is secured.

Sixty years ago a poor monk, named Cottolengo, founded this institute on money solicited by begging. Its support is still obtained in this manner and by private, mostly anonymous, contributions from one day to another. No sick asking for treatment nor any healthy person needing shelter have ever been refused admittance. If the latter is in extreme poverty and wants work and cannot get it outside, it is given him here. Homeless boys and girls receive free schooling. They learn how to read and write, knitting, sewing, embroidering or a trade. So do men and women, the trades of carpenter, shoemaker, tailor, printer, bookbinder. baker and gardener being practically taught

The more skilled laborers are placed in the repairing department. There is constant work for the hospital, also work to fill orders coming from outside. Deaf mutes, the blind incurables, idiots, fallen women and picked-up children are taken in and cared for. Anyone needing a roof over his head, so long as he is poor and destitute and not a criminal, gnds a welcome home here, provided he is willing to work in exchange for shelter and a good meal.

The Cottolengo is a city in itself, managed by a board of business men and physicians, ministered to by a priest and attended by a sisterhood. The question, however, whether the applicant be a Catholic or not, has never yet been raised.

HUNGARY'S ANNIVERSARY.

Great Preparations Being Made for a Millenial Celebration.

Hungarians are making preparations on a grand scale for a millenial exhibition, and the government addressed a prayer to the emperor that he might lend them all the historic relics in his possession which have any connection with Hungarian history. The emperor granted the request and a number of Hungarian historians and antiquarians have come to Vienna to study the imperial collection and make a list of the objects in question. They have selected a great number, which represent a value of 2,000,000 florins-if the value of unique historical relics can be expressed in figures. Among these objects are copies of the portraits in relief of King Mathias, Corvinus and Queen Beatrix, a bronze bust of Mary, queen of Hungary; bronze reliefs of Adrien Fries, illustrating the Hungarian wars; the remnants of the crown of King Andreas and the imperial globe, dating from the fourteenth century; the double cross that belonged to Lewis the Great, with relics of Christ's cross; a map of Hungary engraved in a metal plate, a nautilusshaped cup, with arms of the Batthy-

anis. It is easy to imagine what efforts will be made in Hungary to prevent these objects from returning to Vienna when once they have been in the Hungarian capital; and if they are left there surely Prague would ask for all that referred to Bohemia in the imperial collections, and Cracow for all that referred to Poland.




