22-158 VIII. FINANCIAL REPORTS

Eli Neiburger, Director

Director Neiburger reported that the Finance office was in the midst of transitioning to a new accounting system. He then reviewed the June financial report. It was noted that cash was at \$3,187,385. Tax receipts of \$18,085,819 which is 101.1% of the budgeted amount have been received. The Fund Balance is at \$5,784,869. Total cash receipts through June are at \$18,395,537 with year to date expenditures of \$16,829,874. Currently year to date revenues exceed expenditures by \$1,505,046. Actual cash receipts are 100.01% of the budget with actual cash expended at 96.28% of the budget.

Director Neiburger noted that property taxes and penal fines exceeded their budgeted amounts. Interest income shows a loss due to the decrease in the value of bonds held by the Library. Total revenue is shown at \$18,334,921 with expenditures of \$16,832,274.

22-162 X. LIBRARY REPORT

Eli Neiburger, Director

Director Neiburger provided a comparison of 2019 to 2022 door counts at all locations. He anticipates numbers will continue to rise with resumption of in-person programming. He also noted that programming will be scaled back and better coordinated.

Summer game statistics were shown for lawn and library codes. He noted that 2022 active players have surpassed 2019's record. The summer game spectacular is being held this Saturday at Veteran's Park. Prize books for the game had covers commissioned by local artists.

The Family Search Affiliate Library (LDS) has in library only access and is now available.

The 17th Annual Lego Contest will be held on August 7th at the Kensington Hotel.

Social media and patron comments were viewed.

Director Neiburger also announced that Summer Game building codes were now available in braille.

Martin Schwartz, Associate Professor of Architecture and Kaleena Quinn, Adjunct Professor of Architecture introduced various students.

Students presenting included Devin Derr, Summer Hassan, Carson Stickney, Andre Byl and Eli Forta. Each student presented a brief overview of their individual project: outlining use of space, construction elements, daylighting, wayfinding, patron experience and environmental experience.

Board members expressed their appreciation of the creative ideas shown in the various presentations.

Ann Arbor has a rich musical history as a counterculture center, from MC5 and the White Panthers and Destroy All Monsters to Wolf Eyes and the noise scene of the aughts. There are signs this may not continue into the future. Frankly, these days both the residents and university students skew wealthier, and the soaring cost of living here has pushed both artists and art away. Long standing counter-cultural hubs, such as Arbor Vitae have been shut down. New ones that have sprung up, such as The Electric Eye Cafe haven't lasted long. With rumors that Ypsilanti's Ziggy's may soon close, it feels like DIY, Punk, Experimental & Avant Garde arts are losing their relevance to the residents of Ann Arbor.

For this reason, I think now would be a great moment for the AADL to take on a larger role in preserving and documenting the last 50 years of underground art and music from the area. There are still institutions, namely Encore Records and WCBN (in particular through the individuals involved in its longstanding Local Music Show), with which the library could work to sort out what catalog acquisitions might be the most meaningful, though these institutions, too, are at risk, as evidenced by Encore's relocation and downsizing, not to mention the visible massive decrease in both the size and the movement of the store's local music section over the course of the last 10 years.

Self-released CD-Rs and cassettes, small run vinyl releases, zines and digitizations of live recordings could all be valuable assets in this regard, though it would require the insights of those with a longstanding connection to the local scene to sort out the works most relevant to the broader culture. There are so many amazing tools currently available through the AADL catalog that enable young producers of culture to realize their ideas - it is amazing for me to imagine the music I could have created in this town when I was young if these had been available to me 20 years ago. I think it would be invaluable to enhance this potential for cultural creation in our community by building out an archive of this town's contributions to the national / international "counter-" or "underground" cultural conversation, providing young producers with the context to help them make sense of themselves and their work.


Cash, not including investments, increased \$1,696,639 from \$3,187,385 on June 30, 2022 to \$4,884,024 as of July 31, 2022.


