*Resolved*, that the special assessment roll of Lateral Sewer Assessment District No. 5 in said City of Ann Arbor as certified to this Council by the Board of Review be and the same is hereby confirmed and the City Assessor of said city is hereby ordered to assess and spread upon such lateral sewer assessment roll the sum of ten thousand eight hundred and eight and fifty hundredths dollars (\$10,808.50) the same being the sum of money fixed and determined upon as the estimated cost

of Lateral Sewer No. 5 (street crossing expected) as provided by law and an ordinance of said city entitled "An Ordinance Relative to Sewers" providing for the construction of a system of lateral and connecting sewers in the City of Ann Arbor passed the 21st day of May 1894 and approved the 23d day of May 1894, and on and upon each and every of the regular annual assessment rolls of the City of Ann Arbor for the year in and during which any such special assessment shall or may be payable, and to levy and assess against the the owner or occupants of the lands set down therein the said sums of money on, and upon and against the lands set down in and valued upon said special assessment roll.
