Mayor's Office, May 15, 1901.

I desire to express my entire disapproval of the action of the Common Council relating to the appointment of a city attorney. I herewith record my veto of the appointment and confirmation of Mr. Frank A. Stivers as city attorney.

At the beck of no man, but urged by outraged propriety, I hastened home from my uncompleted business in the east to be here before the expiration of the four days allowed by law for the approval or disapproval of the minutes.

If it be true, as stated by the newspaper, that the president of the Council assured the aldermen that the mayor is anxious to avoid making an appointment, he assumed an authority not justified by the facts or circumstances. Even my enemies would be slow to accuse me of moral cowardice or indecision. I have been ready for weeks and am now prepared to nominate for the position. No living man can truthfully testify otherwise.

The president of the Council had no official knowledge that I was out of the city Monday evening, and it would seem things have come to a pretty pass if the mayor of this intelligent community cannot be absent for fifty hours, including Sunday, without having his legitimate functions assumed by another. This act flavors too much of Tammany tactics to be acceptable to the citizens of Ann Arbor.

So much for the moral side of the question; now a few words are demanded concerning the legal aspect of the case.

Pages 20 and 21 of the charter contain a chapter detailing the duties of the mayor. In sections 46, 47 and 48 these duties are outlined.

In the absence or disability of the mayor, section 49 provides for the performance of the duties named in this chapter by the president of the Common Council.

Another chapter, entirely separate and distinct from this, recorded on pages 16 and 17 of the charter relative to the officers of the city and provides for their appointment by the mayor and under no circumstances by any other person.

All bills drawn on exhausted funds I must disapprove.

That the matter of grading and graveling Hill st. and Oxford Road be deferred until the City Engineer can prepare proper grades for said streets.

The grading and graveling of Observatory and Belser streets was considered and passed upon without recommendation until the matter of the

sidewalk and grade on Observatory street could be decided upon.

The Eighth street culvert was examined, and we would recommend that providing the earth is taken from Jackson avenue that it be deposited thereat.

The matter of cutting down East Kingsley street in front of the property of Mary Sullivan is not recommended.

Whereas, one of the great beauties of Ann Arbor lies in its fine lawns and lawn extensions, of which our citizens are justly proud, and the development of which should be encouraged as much as possible, and

Whereas, noxious weeds and plants

are now permitted to grow and seed upon some uncared-for lawns, and especially upon vacant lands and lots held for speculative purposes, among the most troublesome of which is the dandelion, whose numerous seeds are scattered broadcast by the wind, causing annoyance and damage to many of our citizens who have made heroic efforts and expended large sums of money, amounting in the aggregate to hundreds or possibly thousands of dollars, in the whole city, annually, in their efforts to eradicate said weeds and dandelions, and it has been found impossible to do this so long as even a few other people permit them to grow and seed. Now therefore be it

Resolved, That it is the sense of this Council that these pests should be destroyed, and that the citizens who wish to beautify their homes and thereby the city, should be aided by the Council in so doing.

Therefore the Ordinance Committee is hereby requested to advise with the City Attorney and cause an ordinance to be drafted and presented to Council for its consideration, whereby land owners or occupants shall be compelled under a penalty to destroy dandelions and other noxious weeds and prevent their going to seed on their premises within this city.

On motion the above was adopted.
