FINANCE COMMITTEE REPORT.

To the Common Council:

Your Finance Commit-Gentlemen: tee do not feel satisfied with the present way of paying the labor employed by the City.

Under the present system the time checks which are issued by the Board of Public Works and the Street Commissioner convey no information by which this committee can intelligently audit these accounts.

The banks cannot legally cash these time checks as no warrant has ever been ordered by the council.

There is no way by which it can be quickly and easily determined whether duplicate time checks and warrants have been issued.

To facilitate the above we recommend the following:

First. That a Park Fund be created out of which shall be paid all expense of maintaining the parks.

Second. That a Sidewalk Fund be created which shall be subdivided under the following heads:

- (a). Building Walks.
- (b). Grading for Walks.
- c). Repairing Walks.

Third. That a Street Light Fund be created.

Fourth. That the Street Fund be subdivided as follows:

- (a). Cleaning Streets.
- (b). Cleaning Pavements.
- (c) Repairing Streets.
- (d). New Pavements.
- (e). Special appropriations.

Under the latter head each appropriation made by the Council is to have a seperate account.

Fifth. That for all appropriations made by the council under any fund separate accounts shall be opened by the clerk to which shall be credited the amount of the appropriation and charged the expenditures on the same. be drawn for the same.

That the Board of Works be requested to send to this committee on the Friday before each regular meeting time sheets for each man employed, showing the account for which such labor was rendered as subdivided in this report, the days on which such labor was rendered, the price and amount all duly approved by the Board. These time sheets shall be submitted to the council at each regular meeting and upon being allowed the clerk shall either make a blanket warrant to the Treasurer, who shall be in his office on the day following such council meeting from 3 to 6 p. m. for the payment of these time sheets taking as his receipt these sheets duly receipted by the payee, or the clerk shall issue separate warrents to each payee.

Sixth. That the Board of Public Works be requested to render to the Council their report for the past year and an estimate of requirements for the coming year, estimate being made under subdivided accounts as above.

There are in existence a large number of unpaid warrants. We recommend that the Clerk advertise that all warrents unpaid June 1st be declared cancelled and that new warrants must be issued in the usual way for any unpaid claims.

AN ORDINANCE to amend Section 3 of an ordinance entitled "An ordinance relative to sidewalks," passed March 6, 1893, approved March 11, 1893, as amended by an ordinance passed February 17, 1896, approved February 18, 1896, as amended by an ordinance passed July 18, 1898, approved July 21, 1898, as amended by an ordinance passed April 16, 1900, approved April 18, 1900, as amended by an ordinance passed September 16, 1901.

The common council of the city of Ann Arbor ordain:

Section 1. That section three of an ordinance entitled "An ordinance relative to sidewalks," passed March 6, 1893, approved March 11, 1893, as amended by an ordinance passed February 17, 1896, approved February 18, 1896, as amended by an ordinance passed July 18, 1898, approved July 21, 1898, as amended by an ordinance passed April 16, 1900, approved April 18, 1900, as amended by an ordinance passed September 16, 1901, be and the same is hereby amended so as to read as follows:

Sec. 3. Within the limits hereby specified all sidewalks shall hereafter be constructed of stone flagging of artificial stone (cement) and of no other material, towit:

On Main street between Packard and Catherine streets; on Ashley street between Huron and William streets; on Fourth avenue between Packard and Catherine streets; on Division street between Detroit and Packard streets; on State street between Fuller and Packard streets; on Ann street between Ashley and State streets; on Washington, Liberty and William streets between Ashley and State streets; on east side of Divoit street

between Fourth avenue street; on both sides of the North, East and South University avenues, adjoining the University grounds or campus. and on the east side of Washtenaw avenue, between East University avenue and Hill street; on the south side of Hill street between Packard and Sybil streets; and all other sidewalks within the district bounded and enclosed by the following streets and parts of streets, to-wit:

Main street from Packard to Catherine, Catherine street from Main to Division, Division street from Catherine to Kingsley street, Kingsley from Division to Ingalls, Ingalls street from Kingsley to Huron, Huron street from Ingalls to Twelfth, Twelfth street from Huron to North University ave-North University avenue from Twelfth to Washtenaw avenue, Washtenaw avenue from North University avenue to Hill street, Hill street from Washtenaw avenue to East University avenue, East University avenue from Hill street to Tappan street, Tappan street from East University avenue to Oakland avenue, Oakland avenue from Tappan street to Arch street, all of Arch street, Packard street from Arch to Main, and also upon Geddes avenue from Washtenaw avenue to Observatory street, shall be constructed of stone flagging or artificial stone (cement).

Provided, however, that the Common Council shall have power and authority in its discretion to authorize the construction or repair of a tar or asphaltum sidewalk on and along any street or avenue aforesaid within the district aforesaid. Upon all streets, avenues or parts of streets within the city, sidewalks shall constructed, repaired and renewed of stone flagging, artificial stone (cement), tar or asphaltum, or other material as ordered and required by the Common Council, and all work done and all material shall be in all things firstclass, and satisfactory to the Board of Public Works.

Committee report on the removal of Dean & Co.'s oil tanks:

To the Common Council:

Your committee to whom was referred the petition of L. J. Hoffstetter and others in relation to the removal of Dean & Co.'s oil tanks, together with remonstrance against same, respectfully report that they have carefully considered the matter and find as follows:

- 1. That under the charter the council may, by ordinance, locate oil tanks, and store houses for kerosene, gasoline and other inflamable or explosive oils or fluids.
- 2. That Dean & Co.'s oil tanks and warehouses were erected by permisand authority of the common sion council and cannot be removed except in a court of chancery upon proof that they are a public nuisance and dangerous to health and life.
- 3. That the warehouses contain no oils no other inflamable and hazardous combustibles but are used to store the merchandise carried by them in their regular business.

That since the burning of the barns south of the tanks and the removal of the barn east of the same, the danger of fire has been materially lessened.

- 5. That insurance companies do not deem the tanks extra hazardous for the reason that rates in that vicinity are not increased.
- 6. That the warehouses are neat and compare favorably with all buildings used for such purposes in similar localities.
- 7. That the oil tanks are exposed and unsightly to the residents in that vicinity, and your committee would there-Section 2. This ordinance shall take fore recommend that Dean & Co. be

ordered to wall in their said tanks and cover same with a steel roof under the supervision and direction of the city engineer, and that new pipes be laid in that part of Liberty street proposed to be paved; and that in default thereof that the tanks be ordered moved. Ald. Fischer—Report on charter amendments:

A Bill to amend sections 31, 61, 62, 63, 69, 83, 88, 100, 107, 108, 109, 110, 111 and 130a, and to add thereto two sections to be known as 106a and 106b of an Act entitled "An Act to re-encorporate the City of Ann Arbor, revise the Charter of said City and repeal all conflicting acts relating thereto," heing act number 331 of the Local Acts of Michigan of 1889, approved March 15, 1889, as amended by act number 262 of the Local Acts of 1891, approved March 28th, 1891, as amended by act number 282 of the Local Acts of 1891, approved April 10th, 1891, as amended by act number 368 of the Local Acts of 1893, approved April 27th, 1893, as amended by act number 336 of the Local Acts of 1895, approved March 15th, 1895, as amended by number act 69 of Local Acts of 1897, approved June 2, 1897, as amended by act number 356 of the Local Acts of 1899, approved March 30th, 1899, as amended by act number 278 of the Local Acts of 1899, approved February 16th, 1899, as amended by act number 392 of the Local Acts of 1899, approved May 10th, 1899.

Section 1. That sections 31, 61, 62, 63, 69, 83, 88, 100, 107, 108, 109, 110, 111 and 130a of an act entitled "An

Act to re-encorporate the City of Ann Arbor, revise the Charter of said city and repeal all conflicting acts relating thereto," being act number 331 of the Local Acts of Michigan of 1889, approved March 15th, 1889, as amended by act number 262 of the Local Acts of 1891, approved March 28th, 1891, as amended by act number 282 of the Local Acts of 1891, approved April 10th, 1891, as amended by act number 368 of the Local Acts of 1893, approved April 27th, 1893, as amended by act number 336 of the Local Acts of 1895, approved March 15th, 1895, as amended by act number 469 of the Local Acts of 1897, approved on June 2nd, 1897, as amended by act 356 of the Local Acts of 1899, aproved March 30th, 1899, as amended by act number 278 of the 1899, Local Acts of approved 30th, 1899, as amended by act number 278 of the Local Acts of 1899, approved February 16th, 1899, as amended by act number 392 of the Local Acts of 1899, approved May 10th, 1899, be and the same is hereby amended and that two sections to be known as sections 106a, 106b be added thereto; so as to read as follows:

Section 31. The following officers shall be appointed by the Mayor, subject to the approval of a majority of the members-elect from the Common Council, viz., a city treasurer, a city attorney, members of the Board of Public Works, members of the Board of Police Commissioners, members of the Board of Fire Commissioners and members of the Board of Health. The Common Council may also, from time to time provide by ordinance for the appointment, and appoint for term as may be provided in any such ordinance, such other officers whose election or appointment is not herein especially provided for, as the Common Council shall deem necessary for the execution of the powers granted by this act, and may remove the same at pleasure. The powers and duties of all such officers shall be prescribed by ordinance.

Section 61. The Board of Police Commissioners shall appoint a city

marshal, who shall be the chief of police of the city and shall be subject to the direction and under the control of the Board of Police Commissioners. It shall be his duty to see that all the ordinances and regulations of the Common Council made for the preservation of quiet and good order and for the safety and protection of the inhabitants of the city, are promptly enforced, and when he shall know or learn of the violations of any ordinance of the city or penal statutes of the state, it shall be his duty to enter complaint before one of the justices of the peace of said city and do whatever be necessary to bring the offender to justice. He shall have the same power to serve and execute all process issued by any Justice of the Peace of said city in behalf of said city or of the people of the state, for offenses committed within said city as sheriffs or constables have by law to serve and execute similar process and shall supriots, all disturbances and press breaches of the peace, and for that purpose may command the aid of all citizens in the performance of such He shall arrest all disorderly persons in the city, and pursue and arrest any person fleeing from justice in any part of the state.

He may arrest upon view, and with or without process, any person found in the act of committing any offense against the laws of the state or the ordinances of the city, and forthwith take such persons before the proper magistrate or court for examination or The Board of Police Commissioners shall appoint such numbers of policemen or nightwatchmen as the Common Council may deem necessary for the good government of the city and for the protection of the persons and property of the inhabitants thereof, and may appoint such special policemen from time to time as the Common Council may authorize, when in the judgment of said Board of Police Commissioners the emergency or necessity may so require, and may provide for and appoint sub-ordinate officers for the police and night watchmen.

Section 62. The Marshal shall report monthly, in writing and on oath to the Board of Police Commissioners all arrests made by him and the cause thereof, and all persons discharged from arre; during the month; also, the number remaining in confinement for breaches of the ordinances of the city: and the amount of all fines and fees collected by him which report shall be transmitted by the Board of Police Commissioners to the Common Council at their first meeting in each month. All money collected or received by the marshal, for fines, fees, or for any services performed by him in any official capacity, unless otherwise directed by this act shall be paid into the city treasury during the same month when received and the treasurer's receipt therefor shall be filed with the city clerk.

Section 63. The marshal shall not leave the city without the consent of the Board of Police Commissioners except in pursuit of fugitives from justice or for the arrest of persons charged with a violation of the city ordinances. In the absence of the marshal or his inability to serve, the Board of Police Commissioners may designate any policemen or constable to perform his duties.

Section 69. The officers of said corporation shall be entitled to receive out of the city treasury the following sums in full payment of their services. The mayor, president of the council and aldermen shall each receive and be paid a salary of one hundred dollars per year, payable quarterly; the city clerk shall receive one thousand dollars per annum; the city attorney shall receive six hundred dollars per annum; the treasurer shall be entitled to receive such a sum as the Common Council shall allow not exceeding one hundred dollars per annum; Provided, That the said treasurer shall be entitled to receive in addition to such salary the fees hereinafter provided for collecting the taxes to be levied and

collected in said city. The marshal shall be entitled to receive such compensation, not exceeding eighty-three and thirty-three one-hundredths dollars per month, as the Common Council shall allow; the assessor shall receive such compensation as the Common Council shall allow, not exceeding one thousand five hundred dollars per annum; the Justices of the Leace and constables shall be allowed the same fees as are by law allowed to corresponding township officers; supervisors and all other officers of said city shall be entitled to receive such compensation as the Common Council shall allow, not exceeding two dollars per day for every day actually employed in the performance of the duties of their respective offices; Provider, further, That the Common Council may increase the compensation of any officer whenever authorized thereto by majority vote of the qualified electors of the said city voting at any annual charter election, ten days' notice having been given of the proposed increase.

Section 83. The city marshal and any policeman or nightwatchman may be suspended or removed by the Board of Police Commissioners at their pleas-Any officer appointed by the mayor may be suspended or removed by him, by and with the consent of the majority of the members-elect of the council, and the council may expel any alderman or remove from office any person elected thereto, except justices of the peace, by a concurring vote of two-thirds of all the aldermenelect. In case of elective officers, provision shall be made by ordinance for preferring charges and trying the same, and no removal of any elective officer shall be made unless a charge in writing is preferred, and opportunity given him to make defense thereto.

By Ald. Fischer:

Resolved, That Section 88, sub-division three, be changed so as to prohibit the sale of intoxicating liquor in all that part of the city bounded on the east by Division and Detroit streets and on the north by Fuller street.

Section 88. Sub. Div. 3. To forbid and prevent the vending or other disposition of liquors and intoxicating drinks in violation of the laws of this state, and to define and designate by ordinance that part or portion of the city in which the business of selling or offering for sale spirituous or intoxicating liquors may be carried on, and to prohibit the sale or offering for sale spirituous and intoxicating liquors in all other parts or portions of said city and to forbid the selling or giving to be drank, any intoxicating or fermented liquors to any common drunkard, or to any child or young person, and to prohibit, restrain, and regulate the sale of all goods, wares, and personal propa erty at auction, except in cases of sales authorized by law, and fix the fees to be paid by and to auctioneers.

Section 100. All actions against the City of Ann Arbor shall be commenced by summons, which shall be served upon the city clerk at least six days before the return thereof, by giving him a copy of said summons, with the name of the officers serving the same endorsed thereon; or in case of the absence of the said city clerk from the city, then by leaving such copy with the mayor, endorsed as aforesaid; Provided, That no suit shall be maintained against the city until the claim whereon the same is founded shall have been presented to the Common Council of said city, duly verified, at a regular meeting of the same, for allowance, and until after one regular meeting of the Common Council shall intervene; And provided further, That all claims for damages against the city growing out of the negligence or default of said city, or of any officer, or employe thereof, shall be presented to the Common Council of said city, in the manner above provided, within thirty days after such claims shall arise, and in default thereof thereafter be forever barred; and in any action in any court on any such claim, the claimant shall be required to show that such claim has been duly presented in the manner in this act specified, to the Common Council of said city.

The Common Council Section 107. of said city may provide by ordinance for a police force, and for the appointment by the Police Commission such numbers of policemen or nightwatchmen as they may deem necessary for the good government of the city, and for the protection of the persons and property of the inhabitants; and may authorize the Police Commission to appoint special policemen from time to time when in the judgment of the commission, the emergency or necessity may so require, and may provide for and appoint sub-ordinate officers for the police and night watchmen.

Section 108. The Police Commission may make and establish rules for the regulations and government of the police, prescribing and defining the powers and duties of policemen and nightwatchmen, and shall prescribe and enforce such police regulations as will most effectually preserve the peace and order of the city, preserve the inhabitants from personal violence, and protect public and private property from destruction by fire and unlawful And the Police Commisdepredation. sion may, whenever they shall deem it necessary for the preservation of peace and good order in the city, appoint and place on duty such number of temporary policemen as in their judgment the emergencies of the case may require; but such appointments. unless made in accordance with some ordinance or resolution of the Common Council, shall not continue longer than three days.

Section 109. The city marshal, as chief of police, under the direction of the Police Commission, shall have the superintendence and direction of the policemen and nightwatchmen, subject to such regulations as may be proscribed by the police commission.

Section 110. It shall be the duty of the police and nightwatchmen and officers of the force, under the direction of the Police Commission and chief of police, and in conformity with

riots, disturbances and breaches of the peace, to apprehend any and all persons in the act of committing any offense against the laws of the state or any ordinance of the city, and to take offender forthwith before proper court or magistrate to be dealt with for the offense; to make complaint to the proper officers and magistrates of any person believed to be guilty of the violation of the ordinances of the city or the penal laws of the state, and at all times diligently and faithfully to enforce all such laws. ordinances and regulations for preservation of good order and the public welfare as the council may ordain, and to serve all process issued under any city ordinance and directed to them for service, and for such purposes the chief of police and every policeman and nightwatchman shall nave all the powers of constables and may arrest upon view and without process any person in the act of violating any ordinance of the city, or in the commission of any offense against the laws of the state.

Section 111. The Police Commission may suspend or remove from office any policemen or nightwatchmen for misconduct or other cause at any time, as provided in section eighty-three of this act, as amended. When employed in the performance of duty the policemen shall receive such compensation therefor from the city as the Common Council shall prescribe.

Section 130a. Whenever the Common Council shall order any local or public improvement, the costs of a part or the whole thereof it is proposed to assess and levy on the lands, premises and tenements, which are benefited thereby, they shall by resolution so declare, and determine what part or the whole thereof, shall be levied and assessed upon the owners of the lands, premises and tenements deemed to be thus benefited, and thereupon they shall by resolution fix and determine the district or portion of the city benefited and specify the amount ordinances of the city to suppress all to be assessed upon the owners and against the taxable real estate situate | ker, Kearns, Miller, therein: Provided that no such assessments for the pavement of any street or alley shall be made or collected other than by general tax, unless upon the petition for such pavement, signed by the parties owning a majority of the foot frontage of the real estate on the line of such street or part thereof proposed to be paved.

Sec. 106a There shall be a Board of Police Commissioners in said city. It shall consist of three good and competent men who are electors and taxpayers therein. They shall be appointed by the Mayor, subject to the approval of the majority of all the aldermen elect, and shall hold office for the term of three years and until their successors are appointed and qualified, the said term to commence on the fifteenth day of May.

Sec. 106b. The first members composing such board of Police Commissioners shall be appointed, one for the term of one year, one for the term of two years and one for the term of three years from the date of their appointment: and said Mayor shall annually nominate to the Common Council on the first Monday in May, or as soon thereafter as may be a member of such board, for the term of three years, the members first appointed under this act shall, within ten days of their appointment, meet and organize the said Board of Police Commissioners by the election of one of their number as President, and the Common Council shall thereupon, and at all times thereafter provide said board with suitable office room for its meetings and business uses, and supply books, stationery and record things necessary for the transaction of the business in charge of said board and provide for the payment, in like manner as in other accounts against the city, of all necessary and lawful expenses incurred by said board.

REPORT OF GARBAGE COMMITTEE.

Report of special committee on garbage question.

To the Honorable, the President and the Common Council:

Gentlemen:—Your special committee to which was refered the garbage question beg leave to submit the following report:

In consideration of this matter two points were involved, viz:

(1) How to dispose of the garbage.

(2) How to meet the expense of disposal.

With the first question in mind, on May 15th, last, your committee visited the plant of the Ann Arbor City Rendering Works, for the purpose of ascertaining whether that establishment had sufficient capacity for satisfactorily disposing of the garbage from the city, and whether the management Rehfus & Co., would be willing to give the proposition their consideration.

We find that this plant has sufficient capacity for the purpose, also that the management is willing to discuss the

Coon, matter with the council or its representatives, and if satisfactory terms may be reached, to enter into contract with the city for such a term of years as may therein be determined.

With reference to the second question as to how to finance the project, your committee felt that to be a matter more appropriate to the consideration of the Council as a whole: we would therefore recommend that the matter be taken from the committee and passed upon in open session.

REPORT OF CEMETERY COMMITTEE.

Ann Arbor, May 16th, 1903. To the Honorable the President and the Common Council:

Gentlemen: Your Committee on Cemeteries begs leave to submit the following report:

On the fifteenth last, your committee paid a tour of inspection to Fairview Cemetery, in regard to which we would make the following recommendations:

- (1). That the iron fence be repainted the need for this is urgent, as the fence is already considerably coroded from the effects of the weather.
- (2). That that portion of the Cemetery known as the Old Plot, should be replatted and streets and paths laid out. There are several valuable lots in this section which have never been used or sold; others of which all records are gone: by replotting, these could be regained, and at the same time a marked improvement made in the appearance of that section of the Cemetery.
- (3). That the walks or alleyways be remodeled as suggested below. We find that the present system of graveled alleyways requires too much labor and expense to keep in repair in proportion to the amount of use made of them; we think that more pleasing results would be obtained by filling

these walks to the level of the lots with earth and seeding or sodding the The whole could then be kept in condition by use of the lawn mower. These walks are not used enough in any case to cause the sod to be worn through or damaged by footsteps. was suggested that the earth for this purpose could be obtained from the street cleanings, which would involve no extra expense to the city, and would meet the needs as well as any other Moreover the work need not be done all at once, but gradually, as the sweepings accumulate, thus also cutting down expense.

Your Committee would secommend that this plan be carried into effect at as early a date as possible.

(4). That all present plots, and such as shall in the future be laid out, shall be marked by corner stakes. For this purpose the familiar iron stake with the disk top is recommended.
