To the Honorable the Common Council.

Gentlemen: On account of the permanent absence from the city of Poundmaster George Clancy, the office of poundmaster is vacant. I therefore recommend the appointment of Don A. Stark as poundmaster, with power of Deputy Clerk to the extent of collecting dog license, together with the duties of poundmaster, and assistant sealer of weights and measures, he to receive besides regular fee of poundmaster, 25 per cent of all license money collected by himself.
