Dear Sir—Please issue notice and call for a special meeting of the Common Council of the City of Ann Arbor to be held in the Council Chamber, on Thursday evening, May 18, 1905, at 7:30 o'clock, for the purpose of receiving and considering the report of the sewer committee and the city attorney, to whom were referred the matter of the water at the foot of East University avenue, at Packard street, and to take such action relative thereto as may appear to be necessary.

Ald. Kurtz, as chairman of the sewer committee, reported that the committee to whom the matter of

water at foot of East University avenue on Packard street was referred, had made a visit to said place and found that some person was filling in at outlet of culvert on Packard street in such a way as to obstruct the natural flow of water, and after the city attorney had given his views in the matter and read a proposed bill of complaint, the following resolution was offered:
