From the Water Works Department. To the Honorable Common Council of the City of Ann Arbor: Gentlemen—As the city is about to pave Hill and Church streets, the Water Commissioners have decided that a twelve inch pipe should be continued from where it now leaves off on Hill street to Church street and up Church street to South University avenue to South State street, and up South State street to connect with a ten inch pipe.

As the stand pipe located in the southeast part of the city will have to be connected with a continuous twelve inch pipe, with the exception of eight hundred feet of ten inch pipe on South State street, this is the only way which seems best to follow. Consequently this larger pipe main must be continued before the paying on Hill and Church streets is

commenced.

This will make a direct line of large pipe from stand pipe to Washington street, where water is sup-

plied by stations one and two.

If in your judgment this request cannot be allowed, the paving of Hill and Church streets ought to be delayed until such piping is done. The six inch pipe purchased recently will be used at the south end of Church to Prospect street, and other places in the city needing larger pipe.

The approximate cost of material for the above improvement will be around seven thousand dollars. We therefore ask your Honorable Body to make provisions for same, as we must at once order our pipes and fittings so as not to delay the paving. That the fire hydrants shall be under the exclusive control of the Manager, and no one except the fire department shall use the fire hydrants for any purpose except by permission of the Manager or Superintendent, and every time a fire hydrant is opened by the fire department it shall be reported to the office of the Water Works department.

Sec. 2. Any person or persons violating any of the provisions of this crdinance shall upon conviction thereof be punished by a fine of not exceeding one hundred dollars, or by imprisonment in the Washtenaw county jail or the city lock-up for a term not exceeding ninety days, or by both such fine or imprisonment in the discretion

of the court.

Sec. 3. That all ordinances or parts of ordinances heretofore passed by the Common Council of the City of Ann Arbor, relative to the control of fire hydrants, that would in any way conflict with the provisions of this ordinance be and the same are hereby repealed.

Sec. 4. This ordinace shall take effect and be in force from and after the expiration of ten days from the

legal publication thereof.
