Mayer: Whereas, This Common Council has been applied to in writing by a majority of the owners of the lands which are liable to be assessed for the payment of the construction of the same, praying for the grading and paving of Jackson avenue and Huron street, from the end of the present pavement on West Huron street to the city limits on Jackson avenue, within the corporate limits of the City of Ann Arbor, Michigan; and,

Whereas, The grading and paving of that part of Jackson avenue and West Huron street, within the limits aforesaid, is deemed and declared to be a necessary public improvement;

therefore,

Resolved, That it is hereby declared to be the purpose of the Common Council to cause Jackson avenue and West Huron street, within the limits aforesaid, to be graded and paved under the charter and ordinance of the City of Ann Arbor, and in pursuance of the prayer of said petitioners.
