Order of Assessments**

By Ald. Maulbetsch:

Resolved, that the following curbs and gutters, in curb and gutter districts Nos. 102 to 141 inclusive, within the City of Ann Arbor, Michigan, heretofore ordered, in the opinion of the Common Council are and are hereby deemed and declared to be necessary public improvements.

Resolved, further, that all of the lands, tenements and premises hereinafter mentioned in each particular district are deemed and declared to be benefited by the construction and completion of the respective curbs and gutters heretofore ordered and it is hereby ordered and determined that all of the costs of the said respective public improvements (~~street~~ intersections and fifty per cent of the balance of the costs of said public improvements excepted for districts Nos. 102 to 104 inclusive, ~~and~~ street intersections and twenty per cent of the balance of the costs of said public improvements excepted for districts Nos. 105 to 141 inclusive) shall be and it is hereby ordered to be levied on and assessed against the lands, tenements and premises situated in the respective assessment districts hereinafter designated and the special assessment districts are hereby fixed as follows, to wit:
